TECHNICAL CLARIFICATION TO CONTRACTORS – QUESTION AND RESPONSE

Question #1: Is there messaging that the contractor can provide residents if they have questions about the work being performed in their residential backyard?

Response #1: Yes, please inform them that the City of Petaluma will be upgrading water and sewer piping in their area beginning this summer. Please contact George Howard at (707) 776-3776 or by email at goward@cityofpetaluma.org to make a plan to minimize the disturbance to your property and day-to-day activities.

Question #2: Can the contractor discharge groundwater encountered in the trench work to the City's sewer system?

Response #2: The contractor may obtain a discharge permit from the City to discharge to the sewer system, provided it meets all contaminant limit requirements.

Question #3: For work in residential backyards, is temporary fencing required to be installed?

Response #3: The contractor is required to keep the work area safe and secure at all times, this may include temporary fencing. Temporary fencing and all other items necessary for security of the work area are considered to be included in the various bid items and no additional allowance will be made.

TECHNICAL CLARIFICATION TO CONTRACTORS – QUESTION AND RESPONSE

Question #4 Is landscaping required as part of the pipe bursting activities or other work activities?

Response #4 The contractor shall return disturbed areas to pre-construction conditions in all areas of construction. The contractor shall expect landscaping replacement to occur and possible fence replacement if the existing fence is not preserved or protected in place. This work shall be included in the linear foot price of the sewer main pipe bursting or other various bid items of the project and no additional allowance will be made.

Question #5 What happens if access to the sewer lateral location for pipe bursting activities conflicts with a residential structure within the easement?

Response #5 The contractor shall expect to find conflicts in pipe bursting activities and shall work in a manner to preserve or protect in place structures in the easement. If a structure is unable to be temporarily relocated, excavation around the structure or through an existing structure foundation, that includes saw cutting, hand excavation and replacement of the existing foundation is required. This item is considered to be included in the sewer pipe bursting line item and no additional allowance will be made.

This Addendum No. 1 shall become part of the Contract and all provisions of the Contract shall apply thereto. Bidders shall acknowledge all Addendums in the Bid Schedule.
