#### Tremont Street Widening Project

#### SR 16 to Port Orchard Boulevard

Notice is hereby given that the City of Port Orchard will receive sealed bids for the following construction project. Bids will be received by the City of Port Orchard, at the reception desk at the City Clerk's office, located at 216 Prospect Street, Port Orchard, WA 98366, until **11:00 a.m.**, as determined by the designated bid clock at said location, on **Tuesday May 30, 2017**, and will then and there be opened and publicly read to determine the apparent lowest bidder.

A DBE goal of 18% and prevailing wage requirements are in effect.

The **Tremont Street Widening SR 16 to Port Orchard Boulevard Project** proposes to widen Tremont Street from 2 to 4 lanes, adding median, bike lanes, sidewalks, 2 roundabout intersections, utilities, drainage, landscaping, and other miscellaneous work. The general aspects of this work will involve demolition, erosion control, grading, paving, traffic control, utility work, curb and gutter and ramps, sidewalk, striping, and signing. The total estimated cost for this project is in the range of \$12,000,000 to \$13,000,000. **The number of Working Days for Physical Completion of this project is 390.**

Construction plans, specifications, and contract documents may also be examined at the office of the City of Port Orchard Public Works Department.

The City of Port Orchard reserves the right to reject any or all bids and to waive minor irregularities or informalities and to further make award of the project to the lowest

responsive, responsible bidder as it best serves the interest of the City. Proposals are to be submitted only on the form provided with the Contract Provisions. All Proposals must be accompanied by a certified check, cashier's check, money order or bid bond payable to the City of Port Orchard and in the amount of not less than 5% of the total bid amount.
