Notice is hereby given that the City of Port Orchard will received sealed bids for the following construction project. Bids will be received by the City of Port Orchard, at the reception desk at the City Clerk's office, located at 216 Prospect Street, Port Orchard, WA 98366, until 2:00 p.m., as determined by the designated bid clock at said location, on **Monday April 16, 2018**, and will then and there be opened and publicly read to determine the apparent lowest bidder.

This is a re-advertisement as the original bidding document forms were not complete.

The Bay Street Pedestrian Pathway – Segment #3 Construction Project consists of work to be performed within **80 Working Days to Physical Completion** and consists of the construction of **Segment #3 only** of a multi-modal (bike and pedestrian) pathway approximately one (1) mile in length, located along the Bay Street Waterfront and segmented into eleven (11) defined Segments. This multi-modal pathway will facilitate non-motorized transportation between the downtown and the City Center/Kitsap Transit Foot Ferry Terminal and the Annapolis Dock/Kitsap Transit Foot Ferry Terminal. Segment #3 Construction consists of approximately **1,000 Lineal Feet** of multi-modal pathway and connects the two previously constructed Segments #2 and #4. The general aspects of this work will involve demolition, erosion control, retaining wall construction, grading, paving, traffic control, utility work, striping, landscaping and signing.
