Notice is hereby given that sealed bids will be received at the office of the City Clerk for the City of Port Orchard, 216 Prospect Street, Port Orchard, WA 98366 until **1:00 PM** on **October 9, 2020**, for construction of the Well #11 Modification and Testing and Decommissioning of Wells #1 & #2, Contract No. **C074-20**. No proposals will be accepted after the above-stated time. Immediately following the above-stated time, the proposals will be publicly opened and read.

The project consists of work to be performed within <u>60</u> working days from <u>November 10, 2020</u>, and consists of furnishing all materials, equipment, tools, labor, and other work or items incidental theretofore and as generally described as follows:

The project includes the modification of the City's existing 12-inch diameter Well #11 at McCormick Woods by cutting and removing 520 linear feet of 12-inch diameter casing, leaving a 16-inch diameter pumping chamber. The 16-inch by 12-inch annulus will then be grouted with cement to assure there is no transfer of material through that annulus. The modified well will then be step tested at up to 1,500 gallons per minute (GPM) (if the well allows). The step test will be followed by a constant-rate test for 24 hours at a rate to be determined by the step test results. The contract will also include the proper decommissioning of two older wells (#1 and #2) on the property per WAC 173-160.

The Engineer's estimate of probable construction costs for this project is \$100,000.
