**DESCRIPTION OF PROPOSAL:** Division of a tax parcel into four resultant lots with seven units total (three lots with duplexes, one lot with a single-family residence).

**ENVIRONMENTAL REVIEW:** The City of Port Orchard has reviewed the proposed project for probable adverse environmental impacts and expects to issue a Determination of Nonsignificance (DNS) for this project. The optional DNS process in WAC 197-11-355 is being used, consistent with POMC 20.160. This may be your only opportunity to comment on the environmental impacts of the proposed project.
