The Town Counsel was present.

The Moderator opened the meeting with the Pledge of Allegiance.

A motion was made and seconded to dispense with the reading of the full warrant.

## The Moderator declared the vote UNANIMOUS at 6:22 PM

The Moderator read the charge to the Constable, and the Return of the Warrant.

The Moderator asked that all first time attendees and non-voters identify themselves for the tellers.

The Constable for the meeting was identified by the Moderator as Police Chief, Paul Patriarca.

The Selectboard awarded the Citizen of the Year certificate to John Mirick.

The Moderator read the results from the May 13, 2024 Annual Town Election.

**ARTICLE 1.** Moved and seconded to hear the reports of the Town Officers and any outstanding committees and act thereon.

## The Moderator declared the vote UNANIMOUS at 6:35 PM

**ARTICLE 2.** Moved and seconded that the Town vote under the provisions of G.L. c. 41, §108, to fix the salaries of the following Town Officers for the ensuing year (FY25):

**ARTICLE 3.** The Moderator went through each Department of the FY25 budget to allow voters the opportunity to request that a department or departments be HELD for discussion. Voters requested that the following two budget items be considered separately and these items were HELD for discussion:

Ambulance

Wachusett Regional School

Excluding held items, moved and seconded to approve the balance of the budget for FY25, to raise and appropriate \$6,738,047.77 and to transfer the sum of \$150,000 from Free Cash to reduce the FY25 tax rate and to appropriate \$140,340.00 from Ambulance Receipts for a total of \*\$7,028,927.77 including debt and interest, and to provide for a reserve fund, for the ensuing fiscal year (FY25), as set forth in the warrant and in the corrected handout sheet. *Correction is highlighted*.

\*Town Clerk Note: There was a Scrivener's error that was projected for public viewing and voted on that increased the raise & appropriate by \$540.00. Following the dissolution of town meeting, the Division of Local Services was consulted. The Division of Local Services advised that the number that is voted on is reported on the tax rate recap. Any excess unspent will flow to free cash.

## The Moderator declared the vote CARRIES at 6:45 PM

Moved and seconded to approve the ambulance budget of \$380,817.00.

#### The Moderator declared the vote UNANIMOUS at 6:54 PM

An amendment was moved and seconded to reduce the Wachusett Regional School Discretionary Line funding request by \$200,000.00 so that it reads \$1,220,262.00 and to adjust the Wachusett Regional Total from \$6,106,079.00 to an amount of \$5,906,079.00. An objection was made to the amendment on the floor.

After further discussion, it was moved and seconded to amend that motion by approving the Wachusett Regional School budget as printed in the warrant.

**ARTICLE 4. RECURRING BUSINESS** – Moved and seconded to approve Article 4 as proposed in subsections A through E.

- **A. VOTED** to <u>establish the FY25 trash operating budget</u>. Receipts for trash disposal services received in FY25 and all subsequent fiscal years are to be deposited into a trash enterprise fund account established in FY08. Appropriations from said account are to be made at either the annual or special town meetings for the purpose of paying for the proper disposal of solid waste generated within the town. The requested appropriation for the FY25 trash operating budget is \$10,000 to be <u>appropriated</u> from the <u>Solid Waste Enterprise account</u>. Any balance in said account is to be carried forward to subsequent years.
- **B. VOTED** to transfer \$10,000 from Free Cash to be deposited in the Other Post-Employment Benefits Liability Trust Fund in order to offset future health insurance costs for retirees.
- **C. VOTED** to <u>raise and appropriate \$50.00</u> to the <u>Goodnow Book Expense Account</u> for the purchase of books for the Library, as required by the terms of the Goodnow Deed of Gift.
- **D. VOTED** to transfer \$2,047 from free cash to the School Septic System Stabilization Fund for the purpose of reserving funds for the replacement and/or repair of the septic system at the Thomas Prince School.
- **E. VOTED** to <u>authorize</u> the Selectboard to contract with and <u>accept any grants</u> from the Mass. Department of Transportation-Highway Division for the construction of any road or related work that may be allotted to the Town for the ensuing year.

## The Moderator declared the vote UNANIMOUS at 7:52 PM

#### ARTICLE 5. DEPARTMENTAL REVOLVING FUNDS AUTHORIZATION

The Moderator read Article 5 and announced there was a scrivener's error in the motion. The correct date should be changed from July 1, 2023 to July 1, 2024.
