INFORMATION / BACKGROUND

Mark Shingledecker was appointed to fill an unexpired term on the planning commission for Position #4 which was vacant due to Councilmember Jennifer Jensen’s election to the City Council. That term expired on June 30, 2025. The Mayor recommends re-appointing Mark Shingledecker to this seat for a new 6-year term which will expire on June 30, 2031.

In accordance with RMC 1.07.020, the process for appointing Planning Commissioners is an appointment by the Mayor and a confirmation by the Council. The attached Resolution #815 appoints Mark Shingledecker to Position #4 for a full 6-year term ending June 30, 2031. If Council agrees with the Mayor’s appointment, then adoption of the Resolution is recommended.
