Ruston Storm and Surface Water Manual

Readers Guide

This Storm and Surface Water Manual which has been adopted by the City of Ruston under Ordinance No. 1416 as the "Ruston Storm and Surface Water Manual" was created by the City of Tacoma and adopted as Tacoma's Storm and Surface Water Manual in 2012. The City of Ruston is adopting this Storm and Surface Water Manual for use within Ruston. This "Readers Guide" is made part of the Surface Water Manual in Ruston and is intended to help the users of this Storm and Surface Water Manual apply the contents thereof to activities undertaken within the City of Ruston.

<u>Terms Used in Manual.</u> Wherever, the Manual uses the certain terms listed below, it should be read as outlined in the "Glossary Table" below.

Where specific sections of the Tacoma Municipal Codes are listed in the Manual, the Manual user should review the Ruston Municipal Code to find the most appropriate Ruston provision.

<u>Conflict Between "Storm Water Management Manual" and "Ruston Municipal Code" or "RMC".</u> In the event there is a conflict between the provisions of this Storm and Surface Water Manual and the Ruston Municipal Code that cannot be harmonized, then the specific terms of the Ruston Municipal Code (RMC) shall govern.

North Tacoma Basin Standards. The Manual contains information and provisions for multiple basins within the City of Tacoma. In Ruston city limits, the only basin applicable is the "North Tacoma basin." Where ever provisions in the Manual reference standards specific to basins other than North Tacoma Basin, those specific standards shall not apply.
