INFORMATION / BACKGROUND

The City of Ruston has the authority under state law¹ to sell its real or personal property. The Ruston Police Department recently upgraded its fleet with the purchase of three new police vehicles (automobiles) which has resulted in the Police Department having more vehicles than necessary. There are now three police automobiles and one police motorcycle that are no longer in use. The Police Chief has requested that these four vehicles be declared surplus and sold at auction for fair market value.

RESOLUTION NO. <u>683</u>

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RUSTON, WASHINGTON, DECLARING CERTAIN POLICE VEHICLES SURPLUS AND AUTHORIZING THE SALE OF SUCH VEHICLES.

WHEREAS, in accordance RCW 35A.11.020, the City of Ruston has the authority under state law to sell its real or personal property; and

WHEREAS, the Ruston Police Department recently upgraded its fleet with the purchase

of three new police vehicles (automobiles); and

WHEREAS, there are now three police automobiles and one police motorcycle that are no

longer in use; and

WHEREAS, the four police vehicles described herein are surplus to the needs of the City;

and

WHEREAS, these vehicles should be declared surplus and be sold for fair market value;

NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF RUSTON, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Declaration of Surplus. The City Council hereby declares the following personal property surplus:

- 3. 2006 Ford Crown Victoria (VIN #2FAHP71W56X116871)

Section 2. Police Chief Authority. The Police Chief is authorized to arrange for the sale these vehicles for fair market value on behalf of the City.
