INFORMATION / BACKGROUND

Mike Wagner was appointed to the Ruston Planning Commission on June 19, 2012 by adoption of Resolution No. 511. Mr. Wagner desires to be re-appointed and is eligible and willing to serve another term on the Ruston Planning Commission.

Mayor Hopkins desires to re-appoint Mr. Wagner to the planning commission for his current position. The new term will commence on July 1, 2018 and expired on June 30, 2024.

In accordance with RMC 1.07.020, the process for appointing new Planning Commissioners is an appointment by the Mayor and a confirmation by the Council. The attached Resolution appoints Mr. Wagner to Position No. 3 for a new 6-year term. If Council agrees with the Mayor’s appointment, then adoption of the Resolution is recommended.
