

**ORDINANCE NO. 1418**

**AN ORDINANCE OF THE CITY OF RUSTON, WASHINGTON, RELATING TO RUSTON STORM SEWER UTILITY, AMENDING SECTION 20.02.030 OF THE RUSTON MUNICIPAL CODE TO CROSS REFERENCE THE ADOPTED CITY STORM WATER MANAGEMENT MANUAL AND TO REQUIRE COMPLIANCE THEREWITH, AND ESTABLISHING AN EFFECTIVE DATE.**

WHEREAS, the City operates its own storm sewer utility; and

WHEREAS, the City is adopting public works standards under Ordinance No. 1416 which will be located in Chapter 12.09 of the Ruston Municipal Code; and

WHEREAS, as part of the public works standards adopted by Ordinance No. 1416, the City adopted a "Ruston Storm Water Management Manual"; and

WHEREAS, in order to make the Ruston Municipal Code more user-friendly, appropriate cross-references and housekeeping edits should be made; and

WHEREAS, it is appropriate to add a cross-reference to Section 20.02.030 to the Ruston Storm Water Management Manual adopted under Chapter 12.09 RMC and to make development within the City consistent therewith; and

WHEREAS, on July 16, 2013, the City Council held the first reading of this Ordinance; and

WHEREAS, on August 6, 2013, the City Council adopted this Ordinance during its regular meeting at the second reading; **NOW, THEREFORE,**

**THE CITY COUNCIL OF THE CITY OF RUSTON HEREBY ORDAINS AS FOLLOWS:**

**20.02.030 Storm water management manual.**

~~The mayor or his designee is empowered to direct the preparation of a comprehensive storm drainage plan to identify the needs and most appropriate standards for the Town~~City has adopted a Ruston Storm Water Management Manual under Chapter 12.09 RMC which applies to all development within the City of Ruston.

New development where there is no existing storm system ~~should~~shall provide storm sewer systems in accordance with the standards contained in Chapter 12.09 RMC.

**Section 2. Severability.** If any section, sentence, clause or phrase of this Ordinance should be held to be unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

**Section 3. Publication.** This Ordinance shall be published by an approved summary consisting of the title.

**Section 4. Effective Date.** This Ordinance shall be effective five days after publication as provided by law.


