

**ORDINANCE NO. 1443**

**AN ORDINANCE OF THE CITY OF RUSTON, WASHINGTON AMENDING THE CITY OF RUSTON'S 2014 ANNUAL BUDGET TO INCREASE CAPITAL EXPENDITURES IN THE AMOUNT OF \$85,000 TO PAY FOR THE PURCHASE OF A PUMPER TRUCK FIRE APPARATUS, TRANSFERRING RESERVE FUNDS INTO THE GENERAL FUND (CAPITAL) BUDGET TO PAY FOR THE PURCHASE, DECLARING AN EMERGENCY, AND ESTABLISHING AN EFFECTIVE DATE.**

WHEREAS, on December 3, 2013 the City Council adopted Ordinance #1427 adopting the City's budget for fiscal year 2014; and

WHEREAS, certain expenditures in 2014 could not reasonably be foreseen by the City at the time of the adoption of the 2014 budget; and

WHEREAS, these unforeseen circumstances included the failure of the City's pumper truck fire apparatus which occurred the week of May 26, 2014; and

WHEREAS, the Mayor is declaring an emergency and the emergency exception to public bidding laws is applicable to allow the City to purchase a new (used) pumper truck; and

WHEREAS, the City Council declares that these unforeseen circumstances constitutes an emergency in accordance with RCW 35A.33.090; and

WHEREAS, in accordance with RCW 35A.33.120, the City Council deems it in the best interests of the City to amend the budget as follows:

WHEREAS, the purpose of these fund transfers is to purchase the fire pumper truck to replace the pumper truck that recently failed; and

WHEREAS, the City Council finds that these fund transfers as described above are in the best interests of the City; and

WHEREAS, this Ordinance was first introduced on June 3, 2014; and

WHEREAS, the City Council held a public hearing on this budget amendment on June 17, 2014; and

WHEREAS, more than five (5) days have elapsed since the introduction of this Ordinance as required by RCW 35A.33.090; and

WHEREAS, in accordance with RCW 35A.33.090 and 35A.33.120 on June 17, 2014, the City Council adopted this Ordinance during its Regular Council Meeting which occurred more than five (5) days after this Ordinance was first introduced; and

WHEREAS, the City Council passed this Ordinance with at least four Council Members voting for adoption; **NOW, THEREFORE**

**THE CITY COUNCIL OF THE CITY OF RUSTON DOES HEREBY ORDAIN AS FOLLOWS:**

**Section 1. Amending Budget.** The annual budget for the City of Ruston, Washington,

for the year ending December 31, 2014, is hereby AMENDED as shown on the attached Amended 2014 Budget document, which is attached to this Ordinance 1443 as Exhibit "A" and incorporated herein by this reference.

**Section 2. Copies of Budget to be Kept on File.** Three copies of the Amended Annual Budget adopted herein shall be kept on file in the Office of the City Clerk-Treasurer.

**Section 3. Transmittal to State and AWC.** In accordance with RCW 35A.33.075, the City Clerk-Treasurer is hereby directed to transmit one certified copy of the Amended 2014 Annual Budget which is amended herein to the State Auditor's Office, and a second copy to the Association of Washington Cities.

**Section 4. Severability.** If any section, sentence, clause or phrase of this Ordinance should be held to be unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

**Section 5. Publication.** This Ordinance shall be published by an approved summary consisting of the title.

**Section 6. Effective Date – Emergency.** This Ordinance shall take effect and be in full force and effect immediately upon passage, as set forth herein, as long as it is approved by a majority plus one of the entire membership of the Council, as required by RCW 35A.12.130.


