ORDINANCE NO. 1461

AN **ORDINANCE** OF OF RUSTON, THE REGULAR WASHINGTON, RELATING TO MEETING SCHEDULE OF THE CITY COUNCIL, AMENDING THE SCHEDULE TO REDUCE THE AUGUST MEETING SCHEDULE TO A SINGLE MEETING AND AMENDING SECTION 1.02.020 OF THE RUSTON MUNICIPAL CODE TO REFLECT THIS CHANGE, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, in accordance with RCW 35A.12.110 the Ruston City Council has the authority to set the schedule for regular council meetings, provided such meetings are held at least once per month; and

WHEREAS, the City Council has previously set its meeting schedule as the first and third Tuesdays of every month, such schedule is codified as RMC 1.02.020; and

WHEREAS, the Council has historically canceled the first meeting in August in order to participate in the National Night Out; and

WHEREAS, the Council desires to codify the deletion of the first meeting in August so that it is not included as a Regular Council Meeting; and

WHEREAS, on July 7, 2015 the City Council held first reading of this Ordinance; and WHEREAS, on July 21, 2015, the Council adopted this Ordinance during its regular meeting at second reading; NOW, THEREFORE

THE CITY COUNCIL OF THE CITY OF RUSTON HEREBY ORDAINS AS FOLLOWS:

Section 1.02.020 of the Ruston Municipal Code Section is hereby amended to read as follows:

1.02.020 - Time and place of Council meeting.

(a) Except during the month of August, the TownCity Council shall meet at the Mary Joyce Community Center in the Ruston School on the first and third Tuesdays of every month at the hour of 7:00 o'clock in the evening, except when said meeting date shall fall upon a holiday. In that event the meeting shall be held at the same time and place on the following day. In the month of August, the Council shall have only one regular meeting which shall be held on the third Tuesday at the hour of 7:00 o'clock in the evening at the Ruston School.

(b) That if a request to accommodate a disabled person is made before the close of business on the day of the meeting and the proposed accommodations are unsuitable to the disabled requestor, the meeting will be held at the Town City Hall.

<u>Section 2</u>. <u>Severability</u>. If any section, sentence, clause or phrase of this Ordinance should be held to be unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

<u>Section 3</u>. <u>Publication</u>. This Ordinance shall be published by an approved summary consisting of the title.

Section 4. Effective Date. A summary of this Ordinance, consisting of its Title, shall be published in the official newspaper of the City and shall take effect and be in full force five (5) days after the date of publication.
