From the Police Department

Greetings friends! I am your new chief of police, so it is a pleasure to communicate with you in my first newsletter. My name is Nestor Bautista. I am here to be a partner with a purpose to serve our community and to impart a positive influence on your quality of life. As I pondered the position to be your chief one of the compelling realizations was that this community, surrounded by a much larger government, is determined to maintain local control and govern themselves. This is an admirable feature that is uniquely American, and totally Ruston! I am so honored and proud to be part of your community.

I started my law enforcement career with the Washington State Patrol in 1991 and retired in 2016. I was a trooper until 1998, became a detective until 2002, and then promoted to sergeant. In 2012, I was selected to be a detective sergeant and lead WSP detectives at the regional auto theft task force. In 2013 was assigned to be the task force supervisor. Upon retiring from WSP, I accepted an officer position with the Washington Liquor and Cannabis Board.

It is no surprise to any Ruston resident that many changes are occurring, and whether I am your chief for one more day or many days to come, I vow to leave it better than I found it. I am pleased to report that you have officers who care in the same way that I care about Ruston, and part of my job will be to develop them into the finest officers they are capable of becoming.
