





SERVICE LEVELS & FEES

All services include weekly garbage. For a small additional monthly cost, most customers also choose to add yard waste service, which is also weekly. To encourage cleanliness, all occupied properties in the City of Ruston must subscribe to a minimum of 20-gallon garbage collection weekly per local ordinance.

UNDERSTANDING YOUR BILL

BILLING FREQUENCY

- You will be billed every two months, or six times a year, for two months at a time.
- Your first bill might be for more than two months, depending on when your service began during a given billing cycle.

BILLING DATES

- Bills are generated on a two-month billing cycle and due on the 25th of the same month billed.
- A finance charge of 1.5% or \$1 minimum may be assessed on any past due amounts.
