# CITY OF RUSTON REGULAR COUNCIL MEETING

#### Tuesday, February 15, 2022

#### The City Council of the City of Ruston met on this date via Virtual Teleconference

#### MEETING CALLED TO ORDER

At 7:00PM Mayor Hopkins called the regular Council Meeting to order. Councilmembers present were Councilmember Hedrick, Councilmember Kristovich, Councilmember Huson, and Councilmember Jensen. Councilmember Syler was excused. Following the flag salute, Councilmember Hedrick moved to approve the agenda, with a second from Councilmember Huson, passed 4-0.

#### **PROCLAMATION**

Mayor Hopkins proclaimed the month of March 2022 as Red Cross Month – See attached.

#### **MINUTES**

Councilmember Hedrick moved to approve the minutes for the Regular Council meeting of February 1, 2022, with a second from Councilmember Huson, passed 4-0.

<u>PAYROLL</u> – Councilmember Hedrick moved to approve Payroll of February 5, 2022, with a second from Councilmember Huson, passed 4-0.

MAYOR'S TIME – Mayor Hopkins outlined the remedial action plan the EPA was considering for the former Asarco site. On behalf of the City Mayor Hopkins prepared a formal letter to EPA with our comments to the proposed 5<sup>th</sup> amendment to the Consent Decree. The Consent Decree is a legal agreement that EPA enters with the potentially responsible party of a superfund site. Mayor Hopkins sent the letter out to Council for their review and noted the letter would be posted to the Ruston website. Mayor Hopkins announced a change to the Ruston Fire Department. When former Fire Chief, Don Torbet, retired, the Fire Chief position was split between two Assistant Chief roles. Mayor Hopkins congratulated Assistant Chief Bruce Allen as the new Fire Chief for the City of Ruston and thanked Assistant Chief Anderson for his years of service to the Ruston Fire Department.

CITY OF RUSTON Regular Council Minutes February 15, 2022

Mayor Hopkins shared the move of City Hall to the Ruston School is anticipated for mid-March 2022. The City is waiting for IT to install additional equipment. Once old City Hall is vacated there will be discussions with Council in moving the Ruston Fire Department to old City Hall and the surplus of Myrtle's house.

<u>Councilmember Hedrick</u> – Thanked Mayor Hopkins for his appointment as the Public Safety Liaison to the Council. Councilmember Hedrick had the opportunity to meet with Fire Chief Allen, getting to know a little more about the Fire Department and discussed the changes coming along regarding the mutual aid agreement with Tacoma Fire. Councilmember Hedrick also had the opportunity to meet with Police Chief Bautista and is looking forward to learning how the Council and City of Ruston could support both Fire Chief Allen and Police Chief Bautista and their departments going forward.

<u>Councilmember Huson</u> – Nothing at this time.

<u>Councilmember Jensen</u> — Thanked Mayor Hopkins for proclaiming the month of March 2022 as Red Cross Month. # Chief's Report Ruston Police Department Tuesday, February 15, 2022

#### **Chief of Police:**

During the previous 28 days the Police Department logged 157 calls for service. Calls will include traffic stops, 911 calls or other calls for service. The number is up by approximately 50% from our previous council report and it matches the trend experienced throughout the county. I predict crimes will continue to rise in our region and I generally attribute this to the Blake Decision, the unintended fallout of the antipolice laws of 2021, and the inability for police to book suspects into the Pierce County Jail.

Sarah Ramey, the arsonist suspected of starting at least 2 fires in Ruston is still in the Pierce County Jail. The investigation continues and evidence is being sought to determine if she may have been involved in one other.

The Department has 3 full-time openings after the departure of Shawn Hoey to the Tacoma Police Department. A part-time officer will take Hoey's shift until we can replace him. We currently have one person in the background for part-time work, and with satisfactory performance, will be considered for a full-time position.
