**INFORMATION / BACKGROUND**

Position #2 on the Ruston Planning Commission is currently held by Cliff Kendall. Commissioner Kendall was appointed via Resolution No. 637 expired on September 6, 2016. His term is set to expire on June 30, 2022. The Mayor recommends re-appointing Cliff Kendall to this seat for another 6-year term which will expire on June 30, 2028.

In accordance with RMC 1.07.020, the process for appointing Planning Commissioners is an appointment by the Mayor and a confirmation by the Council. The attached Resolution #744 re-appoints Commissioner Kendall to Position #2 for a second 6-year term ending June 30, 2028. If Council agrees with the Mayor’s appointment, then adoption of the Resolution is recommended.

WHEREAS, on September 6, 2016, the City Council confirmed the Mayor's appointment of Cliff Kendall for Planning Commission Position No. 2 via adoption of Resolution No. 637; and

WHEREAS, Commissioner Kendall's appointment is set to expire on June 30, 2022 and the Mayor desires to re-appoint Mr. Kendall for another 6-year term; and

WHEREAS, in accordance with RMC 1.07.020 the Mayor of Ruston recommends the re-appointment of Cliff Kendall to the Planning Commission to fill Position No. 2 for a 6-year term which will commence immediately upon expiration of his current term on June 30, 2022; and

WHEREAS, Commissioner Kendall's new term will expire on June 30, 2028; and

WHEREAS, in accordance with RMC 1.07.020, the City Council accepts and confirms the Mayor's re-appointment of Cliff Kendall to the Ruston Planning Commission for another 6-year term; **NOW, THEREFORE**

**Section 1. Re-Appointment.** Cliff Kendall is hereby re-appointed to the Ruston Planning Commission to serve as a Planning Commissioner to Position No. 2 which expires on June 30, 2028. Mr. Kendall's new term will commence immediately upon expiration of his current term on June 30, 2022.
