### **Mayors Corner**

At our last council meeting we had a well-attended presentation from the Department of Commerce on Middle Housing. The City received a Middle Housing grant from the State in their effort to have local municipalities support the adoption of middle housing types into our zoning code. Currently our Planning Commission is working on updating our Comprehensive Plan along with integrating the middle housing request from the State. Ruston currently supports several of the "middle housing types" such as Duplexes and ADUs (accessory dwelling units). These are done via a Conditional Use Permit and this process is currently under evaluation by our Planning Commission.

I think it's important for residents to understand that your leadership, the Council and Planning Commission, are under pressure from the State to increase density. We really want to be able to continue to determine how/where to scale density that makes the most sense for our residents. The current legislative session had House Bill 1110 seeking to give the State control over our zoning laws by allowing multi-family units, duplexes and fourplexes, on residential lots and trumping local land zoning laws. There is also little consideration for infrastructure, most notably parking, and the impact that this will have on residential neighborhoods. While the bill did pass the final bill was changed enough that it excluded Ruston from being affected.

The fact that we still have control over our planning and land use decisions is extremely important. As residents, I encourage you all to attend the current Planning Commission meetings and provide input on your vision for the future of our City. This is especially important in the year ahead when Ruston will do its periodic update of the Ruston Comprehensive Plan. It's *your* city, come to the Planning Commission and the Council meetings and have your say!

## From the Police Department

In December of 2021, the Ruston City Council approved a budget that provided the recruitment and hiring of two additional officers. Due to the highly competitive nature of attracting applicants (some agencies offer up to \$25,000 signing bonuses and cash retention benefits), it took nearly 18 months to find, hire and train the right people for our Department. We were very fortunate to fill the positions despite our competition.

On April 1st, the Department started a new deployment schedule that provides the City with 24 hours of law enforcement service for the first time in Ruston's history. Additionally, there will be *two officers on duty* for up to 19 hours in the 24-hour period. This will allow us to safely set and achieve goals/programs aimed entirely toward public safety. One example is the use of high-volume traffic stops to encourage observance of our City Ordinances and to discourage reckless driving by racing vehicles.

But calls for service have also increased over the same period in 2022. A call for service is any incident the police are asked to handle through a 911 call, citizen contact, phone call to the City, etc.

We know that crime throughout the country is increasing, but it is increasing higher and faster in Washington State. The Department is committed to combatting this trend from occurring in Ruston.
