DO NOT START CONSTRUCTION UNTIL A PERMIT HAS BEEN ISSUED BY THE BUILDING INSPECTOR. <u>THE ADMINISTRATIVE FEE FOR WORK PROGRESSED OR COMPLETED WITHOUT A PERMIT IS</u> 12% OF THE TOTAL COST OF CONSTRUCTION WITH A MINIMUM FEE OF \$750.00 & A MAXIMUM OF \$6,000.00

APPLICANT'S INITIAL SUBMISSION TO THE BUILDING DEPARTMENT MUST INCLUDE:

- 1. A properly completed application with notarized signatures where indicated.
- Application filing fee: Residential = \$75.00 / Commercial = \$250.00 (Application fees are non-refundable)
 Full payment of the permit fee;
- <u>Residential</u> = $\frac{15.00}{\$1,000.00}$ of Construction Cost with a minimum fee of $\frac{100.00}{$275.00}$. Commercial = $\frac{25.00}{\$1,000.00}$ of Construction Cost with a minimum fee of $\frac{275.00}{$275.00}$.
- 4. One full size set and one scaled 11" x 17" copies of sealed design drawings prepared by a NY State Licensed Professional Engineer (maximum allowable plan size = 36" x 42")
- 5. Your contractor's valid proof of liability insurance. (Village of Rye Brook must be listed as certificate holder)
- 6. Your contractor's valid proof of workers compensation insurance. (Form # C105.2 or Form # U26.3 / or NY State Workers Compensation Waiver)
- 7. If the Fire Sprinkler System is being installed by a Plumber, the Plumber must file for a separate Plumbing Permit and provide a copy of his Westchester County Master Plumber's License to the Building Department.
- 8. All RPZ or Back Flow Prevention devices associated with the installation of a Fire Sprinkler System must be approved by the Westchester County Department of Health.

It is the responsibility of the applicant, owner, installer or person in responsible charge to notify the Building Department (48 hour advance notice) to schedule any and all required inspections.

Prior to the Building Department conducting a final inspection of the system, the applicant must submit an approval affidavit from the Westchester County Department of Health, an Application for a Certificate of Compliance and pay the requisite fee.
