Applicants seeking to re-roof an existing building with non-like materials must obtain prior approval from the Village Architectural Review Board (ARB). Please contact the Building Department for further information regarding non-like roofing materials.

DO NOT START CONSTRUCTION UNTIL A PERMIT HAS BEEN ISSUED BY THE BUILDING INSPECTOR

APPLICANT'S SUBMISSION TO THE BUILDING DEPARTMENT MUST INCLUDE:

- 1. A properly completed application with notarized signatures where indicated.
- 2. Application filing fee: Residential = \$100.00 / Commercial = \$250.00 (Application fees are non-refundable)
- 3. Your contractor's valid Westchester County Home Improvement License.
- 4. Your contractor's valid proof of liability insurance. (Village of Rye Brook must be listed as certificate holder)
- 5. Your contractor's valid proof of workers compensation insurance. (Form # C105.2 or Form # U26.3 / or NY State Workers Compensation Waiver)
- 6. Permit fee;
 <u>Residential</u> = \$18.00 / \$1,000.00 of Construction Cost with a minimum fee of \$100.00.
 <u>Commercial</u> = \$25.00 / \$1,000.00 of Construction Cost with a minimum fee of \$275.00.

Weekdays: 8:00am to 6:00pm or dusk, whichever is earlier

Saturdays: 9:00am to 4:00pm.

N.Y. State Building Codes for Re-Roofing 1 & 2 Family Dwellings:

- **<u>§N1109.1.1</u>**. When sheathing is removed or replaced during re-roofing exposing the roof cavity and the roof cavity is devoid of insulation, the roof cavity shall be insulated such that the thermal envelope of the ceiling complies with the requirements of the International Energy Code for new construction. (R-49)
- **§R905.1.2.** Ice barrier shall be applied to the sheathing such that it extends from the lowest edges of all roof surfaces to a point measured 24" perpendicular from the inside of the exterior wall of the building.
