A motion made by Deputy Mayor Boulton and seconded by Trustee Frechette authorized the Mayor to sign the annual insurance contract. Vote 5 ayes (Reilly, Boulton, Frechette, Bray and Constance), 0 nays.

The recommendation from the Volunteer/Citizen of the Year Nominating Committee was accepted by the Board in a motion made by Deputy Mayor Boulton and seconded by Trustee Constance naming Mike Lawler Citizen of the Year and Christine Eggleston as Volunteer of the Year. Vote 5 ayes (Reilly, Boulton, Frechette, Bray and Constance), 0 nays.
