Local Law No. 2 of the year 1999

as follows:

Section 1. It is hereby declared to be the policy of the Village of Sackets Harbor that the positions of Deputy Mayor, Trustee and Village Historian are compatible and may be held by the same person when it is in the best interests of the Village, although recusal is required in certain circumstances outlined herein.

Section 2. Notwithstanding the common law doctrine of compatibility of office, Article 3 and Section 3-300 of the Village Law, a person may simultaneously hold the offices of Deputy Mayor, Trustee and Village Historian.

Section 3. In the even the same person simultaneously holds the office of Deputy Mayor, Trustee and Village Historian, then said person must excuse himself or herself, when acting in the capacity of Deputy Mayor or Trustee, in any matters before the Mayor or the Board of Trustees relating to the Village Historian. Furthermore, in matters before the Mayor or the Board of Trustees relating to the Village Historian where said person is acting in the capacity of Mayor, said person must excuse himself or herself and the remaining members of the Board of Trustees shall designate another Trustee to act as Deputy Mayor.

Section 4. This law is adopted pursuant to Section 10 of the Municipal Home Rule Law.
