Section 1. Chapin Alley is hereby designated a one-way street and the only direction of travel by motor vehicle on said street shall be southeasterly from General Smith Drive to North Broad Street.

Section 2. No person at any time shall park a motor vehicle at any time on or within the right-of-way of Chapin Alley.

Section 3. The Department of Public Works shall post signs in accordance with all applicable legal requirements to notify the public of the requirements of this Local Law.

Section 4. This Local Law shall take effect upon filing with the Department of State.
