Section 1. Section 6 of Local Law No. 2 of the Year 1990, as amended by Local Laws Nos. 1 and 2 for the Year 1991 and No. 2 for the Year 1997 and No. 1 of the Year 1998, is amended to read as follows:

Section 6.

A) Classifications of units are as follows:

1. One family residence apartment,
cottage, and mobile home 1 unit
2. Each additional apartment unit,
rental cabin or cottage occu-
pied or rented or available for
rent or occupancy at any time
during the calendar quarter 1 unit
3. Building lots in served areas 1/4 unit

4. Churches, lodges and fraternities 1 unit

B) The Board of Trustees shall periodically set the quarterly pecuniary charge for one unit. Actual quarterly charges for individual properties shall be the amount of the quarterly charge for one unit times the applicable number of units listed above for such property.

Section 2. This Local Law shall take effect on June 1, 2005.
