Section 1. Subsection 9-5(A) Local Law No. 2 of the Year 1987, as amended, including Local Law No. 5 of the Year 1996, is hereby amended, in part, to read as follows:

A) Creation, Appointment, and Organization:

A Zoning Board of Appeals is hereby created. The Board of Trustees shall appoint five(5) members in conformance with the Village Law. The Zoning Board of Appeals shall select a secretary and proscribe rules for the conduct of its affairs.

Section 2. Transitional Provisions. The purpose of this Local Law is to increase the membership on the Zoning Board of Appeals from three(3) to five(5) members. Consistent with the provisions of Sections 7-706 and 7-712 of the Village Law, this Local Law shall take effect upon publication and filing as required by Section 7-706 of the Village Law and as follows. Upon the expiration of the term of office for each current member of the Zoning Board of Appeals, his or her successor shall be appointed for a five(5) year term, which shall expire at the end of an official year. The two(2) new additional members shall be appointed under the authority of this Local Law, one
