Section 2. Transitional Provisions. The purpose of this Local Law is to decrease the membership on the Planning Board from seven (7) members to five (5) members. Consistent with the provisions of Sections 7-706 and 7-718 of the Village Law, this Local Law shall take effect upon publication and filing as required by Section 7-706 of the Village Law and as follows. Upon the expiration of the term of office for each current member of the Planning Board, his or her successor shall be appointed for a five (5) year term, which shall expire at the end of an official year. The existing offices of member of the Planning Board whose terms expire on the last day of the Village's official year ending in December 2010 and December 2011, shall cease to exist upon the expiration of their current term.

Section 3. This Local Law shall take effect immediately upon filing with the Secretary of State.
