A local law Amending Local Law No. 2 of the Year 1987, as modified, providing for decrease in

as follows:

Section 1. Subsection 9-3(A)(1) Local Law No. 2 of the Year 1987, as amended, including Local Law No. 4 of the Year 1996, Local Law No. 2 of the Year 2003, Local Law No. 1 of the Year 2007 and Local Law no. 2 of the Year 2010, is hereby amended in part, to read as follows:

A. Creation, Appointment, and Organization:

1) The Mayor shall appoint five (5) members, and one alternative member, who shall be Village residents, to the Village Planning Board as provided in Section 7-718 of the Village Law. Notwithstanding Section 7-718 of the Village Law and pursuant to Sections 10 and 20 of the Municipal Home Rule Law, an alternate member shall act as a full member of the Planning Board at any meeting, or portion thereof, in which a member of the Planning Board is not present for any reason or has recused himself or herself or by other lawful authority from participation in or voting on any matter.

Section 2. Transitional Provisions. The purpose of this Local Law is to decrease the alternate membership on the Planning Board from two (2) members to one (1) member. Consistent with the provisions of Sections 7-706 and 7-718 of the Village Law, this Local Law shall take effect upon publication and filing as required by Section 7-706 of the Village Law and as follows. Upon the expiration of the term of office for the alternative member of the Planning Board, as established by Local Law No. 1 of the Year 2007, the office of alternate member due to expire on the last day of the Village's official year in the calendar year 2011 shall cease to exist. The remaining office of alternate member shall be for a five year term commencing after the expiration of the term of alternate member which expires on the last day of the Village official year for the calendar year 2014.

Section 3. This Local Law shall take effect immediately upon filing with the Secretary of State.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. _____ of 20____ of the City of _____ having been submitted to referendum pursuant to the provisions of section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the (special)(general) election held on _____ 20____, became operative.

6. (County local law concerning adoption of Charter.)

I hereby certify that the local law annexed hereto, designated as local law No. _____ of 20____ of the County of _____ State of New York, having been submitted to the electors at the General Election of November _____ 20____, pursuant to subdivisions 5 and 7 of section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.


