Department of Public Works shall be made by the property owner at the property owner's expense prior to initiation of water service. In the event that the property owner shall fail to provide the Village Department of Public Works with an adequate opportunity for inspection, the Village Department of Public Works may enter onto the property, re-tap the main line, retrench the pipe and complete the proper inspection. In the event that repairs are required following said inspection, the property owner shall have a period of 15 days to complete those repairs. In the event that the property owner fails to complete those repairs within the 15 days, the Village Department of Public Works may complete the repairs to bring the service to proper standards prior to initiation of service. The cost to the Village for re-tapping, retrenching and any repair required shall be billed to the property owner based upon the prevailing labor rates in effect for the Village of Sackets Harbor at the time the work is performed, plus the cost of any materials provided by the Village. In the event that the property owner fails to remit payment for labor and materials within 30 days from the billing date, the amount thereof shall be subject to the provisions of § 1-12 of this local law.
