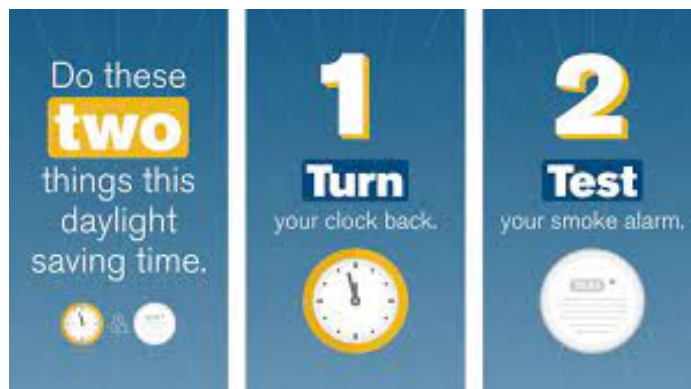

Department of Public Works

Our DPW crews are gearing up for the winter season and fall clean up has begun.

- All Hometown Hero banners have been removed for the season.
- Removal of seasonal meters has begun

- Catch basin Installed next to Harbor Master for storm water trench.

Village Board

The Village Board adopted Resolution #13 of 2023 to adopt Local Law No. 5 of 2023 to the Village of Sacket's Harbor Dog Control Law of the Village of Sackets Harbor Local Law no. 2 of 2001

Definition of Terms:

(o) "Companion Animal" or "Pet"

Means any dog or cat, and shall also mean any other domesticated animal normally maintained In or near the household of the owner or person who cares for such other domesticated animal.

Restrictions

6(e) Chase, jump upon or at, worry or otherwise harass any domestic animal, companion animal, or pet.

Mayor Morgia reported the substantial completion documents for New York Power Authority have been signed off on marking the end of this project. This project replaced streetlights with LED lights whereby saving the village a few hundred dollars In power per month.

He also reports that the remainder of our REDI money will go toward further hardening of the pump station at Brown Shores. This project will will go to bid for construction next year.

Trustee Townsend and Trustee Sova attended the “North Country Prospers” a forum with USDA Rural Development officials from New York State.

The Village Board approved the site of the future Dog Park to be Hill Street. Work Is slated to begin In the spring.

Market Square Park REDI Project Phase 1 Update:

- All sidewalks, shrubs, trees and grass have been Installed.
- All electrical and lighting have been Installed.
- Paver patio Is complete.
- Picnic tables and bench Installation Is expected over the next few weeks.
- Project Is on schedule with the exception of the West boat ramp. Dewatering and progress has been difficult. A solution was proposed and approved to shorten the boat ramp to 60' while slightly Increasing the slope of the ramp from 13.5% to 15% which will allow the same functionality.
- Middle and East floating dock Installation are mostly complete with utility Installation completion over the next few weeks.
