Amendment to the Village of Sackets Harbor's Dog Control Law of the Village of Sackets Harbor Local Law No. 2 of 2001

The existing Local Law shall be amended by the ADDITION of the following sections as follows:

§5 **DEFINITION OF TERMS**

(o) "Companion Animal" or "Pet"

Means any dog or cat, and shall also mean any other domesticated animal normally maintained in or near the household of the owner or person who cares for such other domesticated animal.

§6(e) **RESTRICTIONS**

6(e) Chase, jump upon or at, worry or otherwise harass any domestic animal, companion animal, or pet;
