Department Reports

Department of Public Works

Prior to our January meeting the weather had been relatively quiet allowing DPW workers to do routine maintenance and cleaning of DPW areas, as well as complete breakdown and maintenance of all equipment, tools and machinery. The crews will continue to pick up discarded Christmas trees until they are gone.

Public Notice: Sidewalk Snow

- Property owners are responsible for clearing snow from their sidewalks.
- The village DPW clears sidewalks as a courtesy only *after* they have finished cleaning all roadways.
- Heavy snowfall may delay sidewalk clearing until later in the morning or early afternoon. If you have time sensitive reasons the sidewalk should be clear, you'll need to have backup arrangements for heavy snowfall days business or home

Village Board

Annual reports were received from the Village Zoning Enforcement Officer and the Village Historian.

Mayor Morgia reported attending Watertown's Regional Safety and Logistics meeting regarding the upcoming Eclipse on April 8, 2024. With the expectation of high visitor numbers to our region there are some concerns regarding communication and traffic. He also reported that the Army Reserve will be running a training scenario in the village on January 21, 2024

Trustee Townsend reported exchanging correspondence with Lakeview Estates Subdivision, Madison Barracks to formalize a list of Items that remain outstanding with respect to completion of the infrastructure conveyance process.

Deputy Mayor Mildren reported that the Parks and Recreation committee Is In the process of getting their budget request ready for the upcoming Village Board budget season. He also put a reminder out to all community organizations to submit budget requests in writing to the Village by the end of January.

Trustee Sova reported that the Sackets Harbor Fire Department has established a grant committee to apply to a NYS Volunteer Fire Infrastructure and Response Equipment grant. In addition, the ambulance Is In need and has requested assistance with \$1,738.95 In ARPA funds to replace a broken tablet that EMS personnel use to complete call reports on. The Village Board approved their request.

Market Square Park REDI Project Phase 1 Update:

- A substantial completion walk through was held on 11/3 and a formal punch list was established.
- CO#7 was provided for signature in a credit to the village in the amount of \$11,835 for the west boat ramp changes.
- Substantial completion certificate was provided for signature.

This project will be completed and Market Square Park will be open in the spring.
