SUBJECT: Adopt resolution to award contract for the Miramar/Miraflores Sewer

Replacement Project

RECOMMENDATION:

Adopt resolution awarding contract to Cratus, Inc., for the Miramar/Miraflores Sewer Replacement Project, in the amount of \$1,177,005.

BACKGROUND:

This project consists of replacing approximately 1,650 linear feet of the existing six-inch sanitary sewer mains, 250 linear feet of laterals and rehabilitating existing manholes along Miramar Avenue, Miraflores Avenue, and adjoining easements. Originally, the project was included as part of the City of San Rafael's Third Street Rehabilitation project. However, in the spring of 2023, the contractor for the Third Street project, Ghilotti Bros. Inc., conducted a field investigation and presented to the District a number of site obstructions not detailed in the bid documents. In the meeting between the District and the contractor on March 10, 2023, it was decided that additional time would be required to address the contractor's concerns and given the time constraint to complete the City's project, the sewer pipe replacement work on Miramar and Miraflores Avenues was removed from the Third Street project. After removing the work from the project, the District began making the design updates and revisions necessary to ensure there would be a complete bid package for the work at Miramar and Miraflores Avenues going forward.

This project involves replacing a 450-foot-long segment of the existing sewer main that traverses across five (5) separate private properties. The private properties have significant landscape improvements constructed over the top of the existing sewer main which make it very difficult to perform maintenance service to the main. In order to reduce the maintenance load on the sewer across private property, this project bid included Alternate 1 consisting of a separate 400-foot main extension in the Miramar Avenue right-of-way. Bid Alternate 1 would reroute flow around a difficult maintenance area and reduce the amount of sewer main on private property by 170-feet as compared to the Base Bid. The District reserved the right to award all, none, or any combination of the various bid items including Alternate 1 at the District's sole discretion.

On March 12, 2024, and March 21, 2024, the District published a notice inviting bids for the Miramar/Miraflores Sewer Replacement Project, and bids were opened on April 9, 2024.

The following is the Engineer's Estimate and a list of the bids received:

ANALYSIS:

The Engineer's Estimate for the Base Bid was \$1,352,205.00 with an Alternate 1 total of \$163,675.00. With a Base Bid of \$1,003,215.00 and Alternate 1 bid of \$173,790.00, Cratus, Inc., was the lowest responsible bidder for this project.

District Staff has evaluated the cost benefits of including Alternate 1 together with the award of the Base Bid. Staff recommend that Alternate 1 be included with the award due to the maintenance benefits of moving sewer main from backyard easements to the public right-of-way in the street.

The District's engineering consultant, CSW/ST2, has reviewed their submitted bid package and has recommend that this project be awarded to Cratus, Inc.

FISCAL IMPACT:

Cratus's total bid amount is \$1,177,005.00. This construction project will be funded under the 80-Year Life Cycle Sewer Replacement Program from the FY 2023-24 and 2024-25 Budget.

OPTIONS:

- 1) Staff recommends that the Board award the contract for the Base Bid and Alternate 1 to Cratus, Inc. for the total amount of \$1,177,005.00.
- 2) The Board may award the contract for the Base Bid only to Cratus, Inc. for the total amount of \$1,003,215.00.
- 3) The Board may reject all bids and rebid the project. Staff does not recommend this option since this will delay the start of construction with the risk of sewer overflows and construction costs may increase due to the cost climate.

ACTION REQUIRED:

Staff recommends that the Board adopt the resolution awarding contract to Cratus, Inc., for the Miramar / Miraflores Sewer Replacement Project, in the amount of \$1,177,005.00.

BACKGROUND:

The San Rafael Sanitation District has conducted various emergency spot repairs throughout the years, however since emergency spot repairs are typically unforeseen and thus unplanned repairs, the cost of the emergency repairs is usually high. In order to keep the cost of emergency repairs down, the City of San Rafael has allowed the District to perform a temporary restoration of the pavement, instead of a full pavement restoration during the time when the repairs were performed. The District, however, still needs to do a full restoration of the pavement to comply with City of San Rafael and County of Marin Construction Standards.

The 2024 Paving Repair Project consists of restoring six sections of pavement on five different streets, where sewer repair work was previously completed, but the restoration of pavement wasn't fully restored to comply with City of San Rafael and County of Marin Construction Standards. The 2024 Paving Repair Project intends to fully restore the specified sections by performing a 2-inch asphalt concrete grind and overlay on the streets listed below:

- 1. B Street & 1st Street
- 2. 6 Ross Valley Drive
- 3. Forbes Street & Elizabeth Way
- 4. 110 Ross Street & 112 Ross Street
- 5. Ross Street & Woods Street

RECOMMENDATION:

Adopt a resolution from the San Rafael Sanitation District Board of Directors for accepting the sewer easement at 22 Jewell Street, Assessor Parcel Number 014-072-29.

BACKGROUND:

The City Council of the City of San Rafael passed Resolution No. 1346 accepting the Grant of Easement for the Right of Way and Maintenance of a three-foot-wide Public Sanitary Sewer across 20 & 22 Jewell Street (APN 014-072-27 and APN 014-072-29) recorded in Book 695 at page 123 at Marin County Records, on June 14, 1951. A single-family home was constructed at 20 Jewell Street in 1952, while 22 Jewell Street has remained a vacant lot. The District owns and maintains a 6-inch sanitary sewer across said properties through the existing easement.

The owner of the vacant lot at 22 Jewell Street (APN 014-072-29) applied for a building permit to construct a new residence. The proposed new residence is situated over the top of the existing sanitary sewer main in the middle of the lot.

As conditions of approval, the District required the owners of 22 Jewell Street, Joseph Carfagno and Chantal Perez, to reroute the existing sanitary sewer main around the proposed residence and provide a new sanitary sewer easement. District staff has reviewed the plans for rerouting the sewer around the proposed residence. Additionally, District staff has reviewed the easement deed including legal description and plat prepared by the licensed Land Surveyor hired by the owner. A building permit was issued on March 25, 2024, by the City of San Rafael.

ANALYSIS:

Upon thorough review, District staff has determined that the proposed site grading, rerouting of sewer, and new easement suits the District's needs for gaining maintenance access to its facilities. If the Board elects to accept the new sewer easement, the portion of the existing easement (695 OR 123) across 22 Jewell Street (APN 014-072-29) could be vacated by the Board as a separate action at a later date. The portion of the existing main across 20 Jewell Street will continue to be owned and maintained by the District within that portion of the existing easement proposed to remain.

FISCAL IMPACT:

Other than staff time, there is no proposed financial exchange for this action. Recordation of the Easement Deed with the County of Marin carries no cost to the District.

ACTION REQUIRED:

Staff recommends that the Board adopt the resolution accepting the sewer easement as described in the Easement Deed granted to the San Rafael Sanitation District by Joseph Carfagno and Chantal Perez, owners of 22 Jewell Street, Assessor Parcel Number 014-072-29, and for the Easement Deed to be recorded in the Marin County Recorder's Office.



RECOMMENDATION:

Adopt resolution authorizing the District Manager/District Engineer to sign a third Amendment to Agreement with Nute Engineering for construction related services for Phase B1 of the Bayside Acres Beach Sewer Relocation Project from the amount of \$753,929 to the total amount of \$783,758.

BACKGROUND:

Within the Bayside Acres Beach neighborhood there are 19 homes located along the beach with addresses on Beach Drive, Oak Drive, Marine Drive, and Point San Pedro Road where the homes sit between the road and the beach; and the road is at a higher elevation. Their laterals run down to the beach where the sewer main is located. The sewer was installed in 1972, and at that time, the high tides and sea-level rise were not an issue. At present, our sewer infrastructure is in the tidal zone; and the moderate to high tides cover the manholes, which have lids that have corroded shut. Due to this situation, our staff is unable to access the sewer main to perform maintenance.

Since the Bayside Acres Beach Sewer Relocation Project has many components, District staff and Nute Engineering decided to break the project in several phases. The first phase (Phase A) consists of installing approximately 1,800 feet of new 8-inch sewer main in Oak Drive, Marine Drive, and Point San Pedro Road, where the future laterals will be connected. The second phase (Phase B) will be to install the new private residential pump systems and laterals for each of the 19 properties. Once they have been connected, the District will decommission the existing sewer main in the beach as the last phase (Phase C).

On July 17, 2020, the District entered into a Professional Services Agreement with Nute Engineering for design related services for the Bayside Acres Beach Sewer Relocation Project for \$380,000. On August 8, 2022, the District amended its Agreement with Nute Engineering for engineering services during the sewer main construction of Phase A in the amount of \$40,321. When Nute Engineering and staff began to design the project for the new sewer main, the District had more clear direction on this project which resulted in a second Amendment to the Agreement (September 15, 2022) for additional design services for each of the new private residential pump system and lateral portion of the project, including civil, geotechnical, mechanical and electrical design and permits for \$333,608.

The District is currently in Phase B, focusing on the design and construction of the private residential pump system and laterals. Staff has decided to break this phase into 4 subgroups (B1, B2, B3, and B4), where 4 to 6 properties are in each subgroup based on similar characteristics that will be bid separately. This will help with permitting, design, and overall responsiveness and service by the contractor and managing the construction effectively.

At the January 2024 Board meeting, the Board awarded Pat Nelson Construction, Inc. for the construction of Phase B1 (177, 179, 181, and 183 Oak Drive) of the Bayside Acres Beach Sewer Relocation project. Since it is unknown what each design of the various phases will entail, Nute Engineering did not include engineering services during construction in its proposal. Therefore, Nute Engineering has submitted its proposal to perform engineering services during Phase B1.

ANALYSIS:

Nute Engineering has submitted a proposal for the following services:

- Attend preconstruction meeting.
- Provide on-call construction survey backup.
- Review the contractor's submittals and working drawings as necessary.
- Attendance at weekly construction meetings.
- Attend onsite field meetings if requested.
- Evaluate proposals for modifications to the contract work and assist District in preparing change orders to the contract for the District's approval.
- Prepare a set of record drawings for the project.

Nute Engineering proposes to perform the construction related services for the District on a time-and-materials basis for an amount not to exceed \$29,829.

District staff has reviewed Nute Engineering's additional scope of work and cost estimate and is in agreement with it as presented.

FISCAL IMPACT:

The additional construction related services will be funded under the 80-Year Life Cycle Sewer Replacement Program from the FY 2023-24 Budget.

OPTIONS:

- 1) Staff recommends that the Board approve the increase in Nute Engineering's budget to include the additional construction services for Phase B1 from \$753,929.00 to \$783,753.00, for an additional amount of \$29,829.00.
- 2) The Board may reject approval of the budget increase. Staff does not recommend this option since this will delay the entire project.

ACTION REQUIRED:

Staff recommends that the Board adopt the resolution authorizing the District Manager/District Engineer to sign a Third Amendment to Agreement with Nute Engineering for construction related services for Phase B1 of the Bayside Acres Beach Sewer Relocation Project from the amount of \$753,929.00 to the total amount of \$783,753.00, for an additional amount of \$29,829.00.

Dear Doris:

As you requested, we are pleased to submit this letter outlining the engineering services proposed to be furnished by our firm for the engineering services during construction for the Bayside Acres Beach Sewer Relocation Project – Phase B1.

BACKGROUND AND PROJECT DESCRIPTION

There are 20 homes which are served by the two District sewer pipelines located on the beach within the tidal zone. The District has found these two sewers on the beach to be very difficult to maintain. Homes with addresses on Beach Drive, Oak Drive and on Pt. San Pedro Road are served by these sewer pipelines in the beach. These District sewers drain into two District operated lift stations that pump the sewage up the hill and into other District gravity sewers. On May 20, 2022, the District Board directed District Staff to proceed with the design of private residential pump systems to replace the gravity sewers in the beach and the District operated lift stations.

The Bayside Acres Beach Sewer Relocation Project – Phase B1 is for the construction work to install the residential sewage pump system for 177 Oak Drive, 179 Oak Drive, 181 Oak Drive, 183 Oak Drive, and the pump system force main joint trench within Marin County right of way to Oak Drive. Pat Nelson Construction of Petaluma, CA was awarded the construction contract with the low bid of \$406, 587.

BASIC SERVICES TO BE PERFORMED BY THE ENGINEER

The following is the scope of services we propose to provide for the above project.

<u>Schedule A Services – Engineering Services During Construction</u>

We will assist the District during construction by providing the following services on an as needed basis:

- 1. Attend preconstruction meeting
- 2. Provide on-call construction survey backup.
- 3. Review the contractor's submittals and working drawings as necessary
- 4. Attendance at weekly construction meetings (assume twelve (12) meetings)
- 5. Attend onsite field meetings if requested (assume six (6) meetings)
- 6. Evaluate proposals for modifications to the contract work and assist District in preparing change orders to the contract for the District's approval
- 7. Prepare a set of record drawings for the project

SERVICES NOT INCLUDED IN THIS PROPOSAL

It is understood that the following services are outside the scope of this proposal and will be provided by others:
