Subject: \$5 mil sanctioned encampment plan; request to postpone vote

Dear Mayor and City Council--

We are Gerstle Park residents and have children that attend San Rafael City Schools and the City-run Parkside aftercare and camps, as well as camps at the City-run community center.

While I am enthused that the homelessness issue is on the city council agenda for today, I was surprised to see in the staff report that the city appears to be doubling down on the Mahon encampment which is between Parkside Childcare center and Davidson. Yet the city will remove the encampment from the Falkirk Parking lot because it is near the private Marin Academy? The city appears to be <u>spending \$5 mil on 47 campsites</u>, which also doesn't pencil out in any way.

This is also not an equitable solution.

I note the US Supreme Court decision from this summer and the Governor's <u>directive to</u> <u>start clearing</u> homeless encampments do not seem to have changed the city's plans. We need a real plan to restore our streets and parks to being clean and usable. This plan is not it.

In the last few weeks alone while my kids were at Parkside summer camp or at camps at the City-run Community Center, there have been numerous unhoused individuals outside of Parkside and the community center (sometimes openly doing drugs), sitting on the lawn self-grooming with unleashed pets, or living in a car half a block down the road between Parkside, the encampment and Davidson. When we grocery shop there are frequent disturbances in our local grocery stores, especially Safeway and Sprouts. There was formerly an encampment on the backside of Parkside (moved for baseball season but for weeks our kids could not go outside, and had bottles and other items thrown over the fence.) This is unacceptable, full stop.

The city needs to clear the Mahon and Anderson encampments immediately under the Governor's directive, not allow them to continue to be used and allow open dumping of trash to proliferate on a small creek and bike path, and disturb our kids on the way to school and aftercare or when we shop at local businesses. The boundary for no encampments around schools and childcare facilities should be 1000-2000+ feet minimum if not a complete ban--camping is generally not allowed in the city outside of formal campgrounds. There is no court precedent holding the city back, there is state

money, and the Governor notes that state monies will be withheld from cities that do not act.

It is not an equitable solution to have our public school children bear the burden of an encampment while clearing it near a rather expensive private school, Marin Academy.

There are empty properties near Civic Center if the city wishes to host a sanctioned camp, or share the burden with Ross, Tiburon, Corte Madera, Mill Valley, San Anselmo, etc. Services could be mobile and deliver food if needed--with \$5 mil at play, there are certainly other viable solutions. The city notes there is a county/city partnership on these issues and these are the sort of solutions that need to be explored.

Our Gerstle Park neighborhood, public schools, aftercare and the San Rafael community disproportionately bear the impact of homelessness in Marin and have for far too long. Our neighboring towns do not tolerate this. Even San Francisco has cleared most of its encampments-I drove through clear portions of the tenderloin and civic center just this morning.

Gerstle Park and Bret Harte are full of working class families and Mahon does not serve as an acceptable solution for another 12-18 months and beyond at a price tag of what appears to be \$5 million.

The City of San Rafael needs to strengthen its response and restore our natural areas for the intended community use, while providing safe sidewalks, bikepaths and streets for our kids to use. The ordinance should ban all camping or at minimum extend the buffer between schools and childcare facilities (public and private.)

This issue should be postponed for vote at tonight's city council meeting while the city consults with the affected neighborhoods and schools about solutions, stronger ordinances, and plans to clear impacted parks and bike paths, not to continue a sanctioned encampment in an unacceptable location at a \$5 million price tag for 47 campsites. Permanent housing solutions might be on the table for that amount.

If you noticed the subject line in this email, I have named this issue in your honor, Mayor Kate. Going forward, I will be encouraging other folks to also refer to this unmitigated disaster as "Colinville." Has a nice ring to it, don't you think?
