Then comes along what seems like a proposal that does not fit at all in San Rafael. Over 14 floors tall? 




When will this project be on the City Council meeting?

Dear Chair and Members of the Planning Commission,

On behalf of the San Rafael Chamber of Commerce, an advocate for our 5,128 Marin County employers representing more than 40,428 employees across 25 industry sectors, I am writing to express our strong support for the proposed mixed-use developments at 1230 Fifth Avenue and 900 A Street.

Expanding the availability of housing remains one of the Chamber's highest priorities. Marin County's high cost of living continues to be the single greatest challenge our members face in recruiting and retaining a stable workforce. Employers across all sectors—from health care and education to retail, hospitality, and technology—regularly identify the shortage of attainable housing as a barrier to growth and economic vitality. Adding to our housing supply in a meaningful, strategic way is essential to sustaining a thriving local economy.

These two projects directly advance the goals of the 2021 Downtown Precise Plan, a comprehensive and community-driven roadmap that the Chamber actively participated in shaping. That plan outlines a forward-looking vision for a more inclusive, walkable, transit-oriented, and resilient downtown. At its heart is a clear directive: create new housing within the downtown corridor to support a vibrant, people-oriented environment.

The proposals before you do exactly that.

Project Details

900 A Street (Third & A Streets)

- 131 rental units
- 11 below-market-rate units
- 106 parking spaces
- 8 stories

1230 Fifth Avenue (Fifth Avenue & C Street)

- 187 rental units
- 19 below-market-rate units
- 169 parking spaces
- 13 stories

Collectively, these developments will add 318 new homes, including 30 below-market-rate units, while replacing aging structures well past their useful lifespan. Importantly, these new residents will become customers of our small businesses, patrons of our restaurants, and contributors to the daily vibrancy that keeps local commerce alive. With



fewer workers commuting into the county and more people living near jobs, transit, and services, these developments strengthen both our economic resilience and our climate goals.

Local businesses, especially those that once relied on the foot traffic of full office buildings, are eager to welcome more residents living and working in the heart of San Rafael. Housing in our downtown is no longer a complement to economic vitality; it is a requirement for it.

For these reasons, the San Rafael Chamber of Commerce respectfully urges the Planning Commission to approve both the 1230 Fifth Avenue and 900 A Street proposals. These projects are aligned with the City's adopted downtown vision, responsive to employer needs, and essential to the long-term health of San Rafael's economy.
