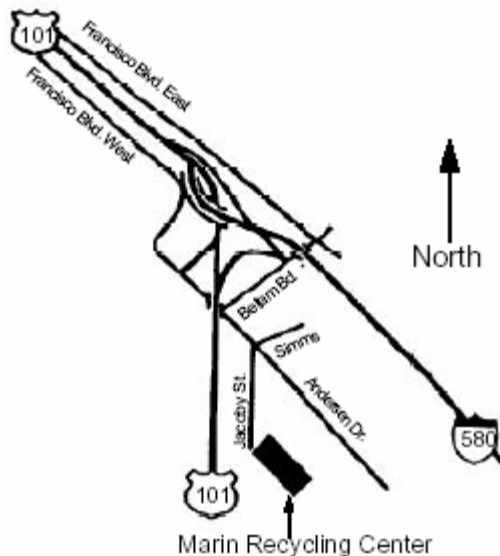


## Directions:

**From North 101:** Take Francisco Blvd. exit. Turn right onto Bellam, make a left onto Andersen. Jacoby Street is the first street on your right.

**From South 101:** Take Francisco Blvd. (I-580) exit from Highway 101, turn right onto Bellam Blvd. and left on Andersen Drive to Jacoby Street. Turn right on Jacoby Street.



### May I Transport It?

You may transport up to 15 gallons of liquid, or a dry weight of 125 pounds. If both liquid and non-liquid, the total amount shall not exceed a combined weight of 125 pound. Liquid weighs 8.5 pounds per gallon.

## Other Restrictions

Some waste types are not accepted at the facility. These include: medical wastes, explosives, radioactives and most compressed gas cylinders.

## EPA ID Numbers

State law requires that every business generating hazardous waste obtain an EPA ID number. To obtain one, call 1-800-618-6942 at the Cal EPA Department of Toxic Substance Control. EPA ID numbers can be assigned over the phone.

## Does Your Business Generate Hazardous Waste?

If your business generates small amounts of hazardous waste, you may have a problem. It is expensive and difficult to dispose of these chemicals, such as paint, motor oil, solvents and acids. Legally, they don't belong in the trash or down the drain. They are hazardous waste, and they must be specially managed and documented. Many businesses have waited for an affordable solution to come along. The City of San Rafael and Marin Recycling Center are offering just such a solution at the permanent hazardous waste facility.

## What is a CESQG?

Most businesses that generate less than 220 pounds or 26 gallons (100 kilograms) of hazardous waste a month are Conditionally Exempt Small Quantity Generators (CESQG). The most common businesses in this group are painters, printers, artists, builders, labs property managers, vehicle repair and body shops, garden contractors, pest control companies and photofinishing shops.

## A CESQG can generate per month:

**Less than** 220 pounds of most hazardous chemicals, or approximately 26 gallons of liquid.

**Less than** 2.2 pounds of certain original unused products (i.e., acutely hazardous wastes). Approximately a quart of liquid.

**Less than** 110 pounds of perchloroethylene. Approximately 13 gallons of liquid.

## By Appointment Only

The City of San Rafael, Marin Recycling, Marin County Solid & Hazardous Waste JPA sponsor the CESQG collection program. This program offers businesses an affordable alternative for hazardous waste disposal. Any hazardous material disposal requires an appointment.

Appointments are scheduled on a first-come, first-serve basis. Businesses call (415) 485-5648 to schedule a time to drop off waste. We ask you the types and amounts of waste generated and your EPA ID number.

## When You Call

To register, the following information is required:

- The name, address and phone number of your company.
- How much waste is generated per month and per year.
- The chemical name or trade name of the waste.
- How the waste was generated and possible contaminants.
- The size, type and number of containers to be brought in.
- Your EPA ID number.

## What Will It Cost?

Your costs will depend on your waste types. Central collection means lower transportation and handling costs. Disposal costs may be lower than what you pay now.

It's your responsibility to know the local, state and federal regulations regarding the storage, disposal and transportation of hazardous waste.
