### 5. NEW BUSINESS

### a. Adopt resolution establishing the sewer connection fee for FY 2015-16.

District Manager Toy reported that District Ordinance No. 56 states that the sewer connection fees shall be adjusted annually by an increment determined by the change in the base index as shown in the Engineering News Record Construction Cost Index (ENR Index) for San Francisco. She also reported that the District Board may postpone this adjustment for any successive year. Manager Toy reported that the ENR Index for May 2015 results in a 2.51% increase and referred to a comparison between the 2014-15 rates and the proposed 2015-16 rates shown in her report. Manager Toy then recommended that the Board adopt the proposed rate increase in order to avoid a potential need for a larger increase at a later date.

- b. Appropriations limit for 2015-16 on tax proceeds (Proposition 4).
  - Adopt resolution establishing the 2015-16 Appropriations Limit.

District Manager Toy reported that the appropriations limit is the maximum amount of tax revenue that the District can receive from State and local governments. She also reported that the District's appropriations limit is updated annually based on a change in population for a portion of both the City of San Rafael and the unincorporated areas and a change in California per capita personal income. She then reported that any tax proceeds used for capital projects can be excluded from the appropriations limit. Next, Manager Toy reported that the District's 2015-16 Appropriations Limit has been calculated to be \$1,067,004, and the tax proceeds are anticipated to be \$1,157,000, which would exceed the limit by approximately \$90,000. She then reported that because the revenue to be spent on capital projects in 2015-16 will exceed \$90,000, the District will be permitted to spend all of its anticipated tax proceeds.

### c. Adopt resolution approving the 2015-16 and 2016-17 Budget.

Mr. John Maher reported that he and Manager Toy had discussed the roll-over of unspent capital improvement project funds from one year to the next. He then presented three different versions of the 2015-16 and 2016-17 Budget as an approach to this matter [Format A (historical format); Format B (single fund, smoothed additions to reserves); and Format C (segregated "capital" funds and "smoothed" transfers)]. He reported that the current capital improvement project (CIP) policy is to set aside 50% of the subsequent year's planned expenditures. He also reported that the cost to replace 1.6 miles of sewer is approximately \$4.5 million per year. Mr. Maher reported that he felt it would be helpful to fund a more stable or "smoothed" amount whereby unspent funds would accumulate and any expenditures would reduce the reserves. He reported that there are basically two approaches to address this matter. The first would be to have a single fund with smoothed additions to the reserves. The second would be to adopt a smooth contribution to separate funds. He then reported that monies would be deposited into these funds annually on a regular basis, and any unspent monies would remain in those funds as reserves. Next, Mr. Maher explained the difference between restricted and committed funds. He reported that restricted funds must be spent on their intended use, and committed funds are designated and can be changed by formal Board action. He also reported that there are also assigned funds, which can be designated by internal designation. Mr. Maher then reviewed the three budget format options with the Board. He reported that Format A is the current format and includes all activity in one fund with no change in policy (uses 50% of subsequent year's planned expenditures for CIPs and is shown under Ending Fund Balance as "Committed"); Format B also includes only one fund and provides that book entries would be used to segregate money for the various reserves; Format C would separate three reserve funds from the Operating Fund. The Operating Fund would make transfers to the restricted funds in amounts that represent the average of the annual expected expenditures over a designated future multi-year period. In response to the Board's inquiry, Mr. Maher reported that he preferred Format C because the capital funds are segregated from the Operating Fund, which would show that the Board is very intentional about providing for the CIPs. Chairman Phillips then reported that he liked the smoothing concept due to the fact that the CIPs will be performed over a long period of time and smoothing would allow for more stability in the Operating Fund. He also reported that a reserve amount would need to be decided upon. Mr. Maher reported that current estimates indicate that in 2015-16 the reserves would start off at approximately \$6.3 million and would drop down to approximately \$3.3 million and would remain around that amount. Director Bushey reported that she liked having segregated funds so that the operating budget would not be driven by the timing of the capital projects. Mr. Maher then reviewed the budgeted figures in Format C with the Board. He recommended that the Board consider increasing Contingencies from its current amount of \$1 million, which was established as a minimum amount. After some consideration, the Board directed that they would prefer that "Contingencies" be renamed "Emergencies." The Board then discussed the possibility of putting some of the Unassigned funds into the 80-Year Plan but decided to wait one more year before

making this decision. The Board then discussed reserves. Mr. Maher reported that although the unassigned fund balance is currently projected to drop by approximately \$1 million per year, he expected that the District would be able to reduce the budget for Pump Station & Force Main Capital Improvements in approximately 3 years by about the same amount. The Board then discussed how \$5 million might best be used if it was taken from the reserves and used for capital improvements. Director Bushey suggested that the best use for these funds might be for a special project, such as the prevention of rainwater/saltwater intrusion. She also suggested doing a study to determine the most intrusive sites. Manager Toy then reported that she would need a chance to consider the options for how best to use \$5 million. Mr. Maher then reported that there were no major changes to the Supporting Schedules except that there would be one additional staff member per year over the next 2 years—an additional engineer and an additional administrative assistant. Director Rice then inquired about a lateral grant program, and Manager Toy reported this might be considered a gift of public funds. She reported that she would prefer to have a lateral loan program, and the Board then recommended that the District offer some type of lateral program as an incentive for lateral replacement. Manager Toy also reported she was going to see how Las Gallinas Valley Sanitary District was doing with their recent lateral loan program.

MOTION by Director Bushey, seconded by Director Rice, to adopt the amended the resolution (a) approving and adopting the 2015-16 and 2016-17 Budget as proposed in Format C (establishing capital funds separated from the Operating Fund) and changing the word "Contingencies" to "Emergencies," (b) establishing separate accounting funds for the Operations, Equipment Acquisition, the 80-Year Life-Cycle Sewer Replacement Program, and the Pump Station & Force Main Capital Improvements Program and separate accounts for the 80-Year Life-Cycle

Sewer Replacement Program and the Pump Station & Force Main Capital Improvements Program with the Marin County Treasurer, and (c) authorizing a policy to make annual transfers from the Operating Fund to the Equipment Acquisition Fund, the 80-Year Life Cycle Sewer Replacement Program, and the Pump Station & Force Main Capital Improvements Program in amounts approximating the average projected annual expenditures.

- d. Report on bid opening for the Warner Court Sewer Improvements Project.
  - Adopt resolution awarding contract to D & D Pipelines for the Warner Court Sewer Improvements Project.

District Manager Toy reported that Warner Court has two separate sewer mains which run through the front yards of the properties on each side of the street. She reported that the District plans to abandon those lines and install a new sewer main in the middle of the street. She reported that the District had received four bids, which were opened on May 21, 2015, and the engineer's estimate was \$250,000. She also reported that D & D Pipelines was the low bidder with a bid of \$227,291. Manager Toy reported that they had submitted a complete bid package but had forgotten to notarize one of the documents. She reported that staff called them about this matter, and they submitted the notarized document the next day. She then requested the Board to waive this irregularity. Manager Toy also reported that D & D Pipelines had previously done a project for the District back in 2006. She then reported that District staff had checked their references on previous jobs for the City of Palo Alto and the City of Burlingame, and everyone had positive comments about them. Director Rice then reported that because the District would only be replacing the lateral from the old main to the new main, she felt that this project would present the perfect opportunity for the District to offer something to the property owners that would help them replace their entire lateral. Manager Toy then reported that when the District replaces the sewer main and the lower laterals, the contractor usually offers the property owners a favorable rate if they choose to replace their upper lateral at the same time. Manager Toy reported that the cost for a sewer lateral replacement is usually between \$5,000 and \$10,000.

# e. Adopt resolution entering an agreement regarding improvements in sewer easement at 45 Dunfries Terrace.

District Manager Toy reported that the District has a 5-foot wide sewer easement on the west side of 45 Dunfries Terrace. She also reported that there is a 6-inch clay pipe and a manhole within this easement. Manager Toy reported that around the end of last year or the beginning of this year, the property owner decided to build a fence and a retaining wall within this easement, which are located pretty close to the District's sewer main. She also reported that because the owner had raised the grade of this property, the manhole was now 2 feet below grade, which makes it inaccessible. Manager Toy then reported that although the District does not currently allow property owners to construct any permanent structures over its easements, back in 1962 the City entered into an agreement with the property owner allowing the construction of these structures within this easement. She also reported that this agreement states that if the District damages these structures, it would have to replace them at its own cost. Next, Manager Toy reported that the District had televised the sewer main and found it to be in good condition. She reported that District staff had met with the property owner's attorney and had agreed to let the current structures remain. She also reported that the property owner would be responsible for removing and replacing any new improvements if the District needed access to its sewer facilities. Manager Toy then reported that the current owner is now selling this property and that escrow would be closing tomorrow. She also reported that the District's legal counsel, Jack Govi, had already approved this agreement and that she had previously reviewed this matter with Chairman Phillips.

### **RECOMMENDATION:**

Adopt the resolution awarding contract to JMB Construction, Inc., for the Glenwood Pump Station Improvements Project.

### BACKGROUND:

The Glenwood Pump Station was built in 1956 and collects wastewater from the Glenwood residential neighborhood. The pump station structure is reinforced concrete with two dry pit pumps located in a below ground pump pit. The pump motors are located below ground, so they would be subject to flooding if a pipe were to break. Also, the pump station site is low and is subject to flooding. The project will consist of replacing the pump station with submersible pumps, increasing the capacity of the pumps, adding a third pump as a backup, and raising the site to a level that is above the flood elevation.

The Bids for the Glenwood Pump Station Improvements Project were opened on July 9, 2015.

### **ANALYSIS:**

The Engineer's estimate was \$1,500,000.00. JMB Construction, Inc., with a bid of \$1,795,085.00, was the lowest responsible bidder for this project. We have reviewed the bids, and both District staff and Nute Engineering recommend that this project be awarded to JMB Construction, Inc.

An Alternate Bid Item for deepening the pump pit was also included in the bid. JMB bid this item at \$112,770.00, which is somewhat consistent with the other contractors' bids. A deeper wet well is a preferable design, as this would prevent the influent pipe from becoming surcharged during the normal operation of the pump station. If the District awards both the base and the alternate bid to JMB, the total amount would be \$1,907,855.00.

### FISCAL IMPACT:

Nute Engineering will provide construction management support. District staff will perform the construction management on this project. The project will be funded under the Pump Station and Force Main Capital Improvements Program from the 2015-16 Budget.

Report on Wildwood Way Sewer Pipe Bursting Project

### BACKGROUND:

Last month, the City of San Rafael Department of Public Works contacted the District and advised us that they will add 10 potential streets to their resurfacing project for this summer and asked if we would have any sewer work on those streets in the near future. Although, we did not have any work scheduled, the sewer pipes were televised in order to check the condition of the pipes. We then discovered that one of the pipes on Wildwood Way (in the Fairhills neighborhood) needed to be replaced. The pipe on Wildwood Way is approximately 320 linear feet, is made of vitrified clay, and has longitudinal cracks, offset joints, root intrusions, and voids. This pipe will be replaced by the pipe bursting method.

Since our estimate of the project was less than \$35,000, we were able to bid this project as an informal bid per Public Contract Code Section 20783.

The following bids were received:

Advanced Trenchless, Inc.	\$28,750.00
Hardiman Construction's Trenchless Titan	\$34,500.00
Roto-Rooter	\$59,850.00

We have informed Public Works that we will need to replace our sewer main on Wildwood Way, and they have incorporated language in their Street Resurfacing 2014-15 contract specifications that will provide for Wildwood Way to be resurfaced at the end of the project.

### ANALYSIS:

Advanced Trenchless, Inc., with a bid of \$28,750.00, is the lowest responsible bidder for this project. They have also submitted a separate bid of \$5,950.00 for replacing one lower lateral that connects to the sewer main. We worked with Advanced Trenchless in early March on a small pipe bursting repair, and the job was successful. Since the total bid amount for the replacement of the sewer main and a lower lateral is \$34,700 and meets the requirement for an informal bid, we will award this project to Advanced Trenchless, Inc, for the amount of \$34,700.00

### **FISCAL IMPACT**:

District staff will implement the construction management on this project. The project will be funded from the Rehabilitation of the Gravity Sewer System (80-Year) in the current 2015-16 Budget.

Re: Revision of the Standard Specifications for Side Sewers and Laterals Proposal for Engineering Services

Dear Doris:

In accordance with your request we are pleased to submit the following proposal to revise the District's Standard Specifications for Side Sewers and Laterals.

### BACKGROUND

San Rafael Sanitation District currently has a Standard Specifications for Side Sewers and Laterals which is a separate document from the District's overall Standard Specifications. The purpose of this specification is to act as guidance for homeowners or builders for the construction of new laterals or rehabilitation of existing laterals. The current document covers:

- General information including issues such as jurisdiction, ownership, permitting and prohibited wastes.
- Design requirements including pipe material, pipeline construction, cleanouts, residential pumping systems and abandonment of facilities.
- · Construction requirements including inspection and testing
- Lateral Details and Drawings

The District would like to revise the current specification by eliminating redundant sections with the overall Standard Specifications and update the specifications to meet current construction methods and materials. In addition, the new specification is intended to meet the needs of the other sanitary agency within the City of San Rafael, Las Gallinas Valley Sanitary District in order to provide consistent requirements for residents in San Rafael, regardless of which District they reside.

### PROJECT OBJECTIVE

The objective of the revision of the Standard Specifications for Side Sewers and Laterals is to have a standalone document for both agencies to distribute to property owners, home builders, and plumbers for the purpose of constructing new laterals and rehabilitating existing laterals

Key to this objective will be to research other regional sewer agencies standards for side sewers and laterals, and identify successful approaches for the District's consideration. We will meet with both Districts' staff to consider the proposed elements of the standards and finalize the document for eventual distribution.

### SCOPE OF WORK

The following is the scope of work for the Revision of the Standard

- Review the current SRSD/LGVSD specifications for side sewers and laterals and compare with each agencies Standard Specifications and Drawings.
- Conduct an internet literature search and call regional sanitary agencies for the purpose
  of collecting other example standard specifications for side sewers and laterals and
  prepare a table of specification features for comparison, including standard lateral
  drawings.
- Meet with both SRSD and LGVSD staff members for a "brainstorming" session to present the summary of the existing specifications and compare to findings of search results of other regional sanitary agencies.
- 4. Develop draft specifications based on comments received from the above "brainstorming" session including revising standard drawings.
- 5. Deliver draft specifications to agencies for their final review, meet and discuss comments.
- Finalize the Standards and provide each agency 5 copies and electronic version for their reproduction.
- 7. Drawings shall be provided in both .pdf and AutoCAD format.

### DISTRICT COORDINATION

In conducting this revision of the Standard Specifications for Side Sewers and Laterals we believe it is important to work closely with District Staff to identify what has worked in the past with the public perception of the lateral standards and what ways they can be improved.

### **ENGINEERING FEE**

We suggest a budget of \$18,000 for the Revision of the Standard Specifications for Side Sewers and Laterals.

Subject: CMSA Future Revenue Planning

Dear Gary,

CMSA's Board of Commissioners received a presentation on the Agency's draft FY 2015-16 budget at their May 12, 2015 Board meeting. Included in that presentation was a review of the updated 10-year Capital Improvement Program (CIP) and revised 10-year Financial Forecast (Forecast). The Board uses the Forecast to estimate future revenues and expenses, project uses of restricted and unrestricted reserve funds, and plan adjustments to operating and capital revenues. In 2013, the Board approved a 5-year revenue program (FY 14 – FY18) to balance the Agency's operating and capital budgets during that period, and provide funding for future year CIP activities. The Forecast incorporates the negotiated 2014 contract labor agreement compensation and benefit adjustments with all employee groups.

As you know, the Agency refinanced its 2006 Revenue Bonds in April 2015 saving the JPA member agencies approximately \$15 million in debt service and coverage expenses over the remaining 17-year bond term. Debt service coverage is a bond covenant, and is 25% of the annual debt service payment. Debt service coverage revenue from the JPA members is utilized by the Agency as a dedicated CIP funding source. Thus, the bond refinancing savings resulted in a reduction in the Agency's coverage revenue and we project a CIP funding reduction of approximately \$1.6 million over its 10-year planning period, lowering the CIP funding level to 83%. The current Forecast indicates that the CIP reserve fund will be depleted during FY 2021. In addition, the Agency projects that annual operating expenses will exceed operating revenues by FY 2019, requiring the Agency to begin using operating reserves to balance its operating budget, with operating reserves projected to be depleted by FY 2022.

When the Agency was discussing the disposition of the savings resulting from the bond refinancing with the member agencies, the coverage reduction factor was discussed and the member agencies understood the need to rebuild the Agency's CIP reserve fund in the future.

Next year, the Agency's Finance Committee will be working with CMSA staff to develop the next 5-year revenue program to provide funding for the future projected operating and CIP shortfalls described above. Our General Manager will then confer with the JPA district managers on the revenue program alternatives, and present the preferred alternative to the CMSA Board for review, discussion, and consideration of implementation. This collaborative development, review, and selection process was successfully utilized during the development of the current 5-year revenue program.
