5. NEW BUSINESS

The Board decided to skip to Item 5.g.

g. Discuss Joseph and Margaret Caramucci letter dated June 29, 2016, regarding the Glenwood Pump Station Improvement Project.

District Manager Toy reported that the letter dated June 29, 2016, from Joseph and Margaret Caramucci was received on July 1, 2016. She also reported that Mr. and Mrs. Caramucci live at 8 Surfwood Circle, which is next door to the Glenwood Pump Station. She then reported that the Glenwood Pump Station has been under construction since October 30, 2015. Manager Toy reported that this letter refers to the events that occurred on June 29, 2016, when the PG&E crew was working at the Glenwood Pump Station. She reported that PG&E had to remove a transformer by using a crane to load the transformer onto a flatbed truck. Mr. Caramucci then reported that he had taken his wife to a medical appointment on June 29th and that upon their return, they were unable to access their driveway or park in front of their home due to the flatbed truck, crane, and PG&E trucks parked in front of their home. He reported that he was forced to park three houses away. He also reported that Senior Civil Engineer Chew offered her assistance when she saw him taking pictures of the vehicles, but he was not pleased with her response. Mr. Caramucci reported that he had written the letter because he was upset over this incident and felt that there was a lack of timely communication. He also expressed his frustration with the on-going project. Mrs. Caramucci then read a prepared statement in which she expressed her frustration with the project and the many inconveniences it has caused, such as the loss of use of her dining room because her crystal and china are being stored there due to the vibrations and not being able to wear her hearing aids because of the noise. She also referred to some cracks both inside and outside the home that she felt were due to the project. The Board and staff then discussed these issues with Mr. and Mrs. Caramucci. Manager Toy reported that the process for handling any damages resulting from a CIP project is to file a claim with the contractor since the contractor signs an agreement to indemnify the District and to hold the District harmless. There was also a discussion regarding

an antenna and light pole at the pump station, and Manager Toy reported that the District was looking into various options for them. She advised Mr. and Mrs. Caramucci that staff would meet with them once all of the information had been gathered.

a. Adopt resolution establishing the sewer connection fee for FY 2016-17.

District Manager Toy reported that according to the District's ordinance, the Board may adjust the sewer connection fee by an increment determined by the change in the base index as shown in the Engineering News Record Construction Cost Index (ENR Index), or the Board may, at its discretion, postpone this adjustment. She reported that the ENR Index for May 2016 would allow the District to increase the connection fee by 3.41% and recommended that the Board increase the fee in order to avoid a larger increase in the future.

b. Appropriations limit for 2016-17 on tax proceeds (Proposition 4).

• Adopt resolution establishing the 2016-17 appropriations limit.

District Manager Toy reported that the California State appropriations limit was established by Proposition 4, which places an upper limit on the amount of money the District can spend each year from State tax proceeds. She also reported that the appropriations limit is updated each year and is based on the change in population, which includes both the City of San Rafael and the unincorporated areas, and also the change in per capita personal income. She then reported that if the District's appropriations limit is less than the amount or tax revenue received from the State, the District can still keep the difference as long as it is spent on capital improvements. Manager Toy reported that the District's 2016-17 appropriations limit is \$1,125,796, and the State tax revenue is anticipated to be approximately \$1,180,000, which is approximately \$55,000 more than the limit. She then reported that this will not be a problem because this money will be spent on capital improvement projects.

- c. Report on Adoption of Investment Policy.
 - Adopt resolution approving the Marin County investment policy as the investment policy for the San Rafael Sanitation District.

District Manager Toy reported that the California Government Code requires all special districts to adopt an investment policy annually. She also reported that because the District maintains all of its cash with the County of Marin's pooled cash and investments, the County's investment policy also serves as the District's investment policy since the County does all of the investments for the District. Manager Toy then recommended that the Board adopt the County's investment policy.

d. Review Budget Status Report for the period 1-1-16 to 3-31-16.

District Manager Toy reported that this is the third quarter report for Fiscal Year 2015-16. She reported that \$66,363 in sewer connection fees had been collected, which was mainly due to the connection fees from the new Marin Academy science center and a new mixed-use building at 1700 Fourth Street. She also reported that the District had received \$6.9 million in sewer service charges, which is approximately 55% of the total amount due. Manager Toy then reported that the District had paid the City of San Rafael 72% of the contractual amount owed and that the rest of the expenditures were fairly routine.

e. Adopt resolution authorizing the District Manager/District Engineer to execute a Professional Services Agreement with Miller Pacific Engineering Group for geotechnical construction observation and testing services for the Sun Valley Sewer Replacement Project, Phase 2.

District Manager Toy reported that at the May Board meeting, the Board had awarded the Sun Valley Sewer Replacement Project, Phase 2, to Ranger Pipelines. She also reported that the District now needed to find someone to perform the geotechnical observation and testing services. She then reported that because Miller Pacific Engineering Group had performed the geotechnical investigation and consultation services for the design portion of this project, the

District had asked them to provide a quote for the construction phase. Next, Manager Toy reported that Miller Pacific had submitted a proposal to perform the geotechnical observation and testing services on a time-and-materials basis for an amount not to exceed \$29,000.

f. Adopt resolution approving a Second Amendment to the Agreement Between the City of San Rafael and the San Rafael Sanitation District for the Transfer of City's Sanitary Sewer Gravity Collection System to the District.

District Manager Toy reported that this item is a follow-up to the September 2015 Board meeting when John Maher of Maher Accountancy discussed the new requirement by the Government Accounting Standards Board (GASB) that requires government agencies to record the full liability for pension and post-employment benefits from the past in their financial statements. She also reported that Mr. Maher had discussed how the City of San Rafael and the District have an agreement from 1987 that states that the District agrees to pay the city for all costs associated with the contractual administrative, operational, and maintenance costs for the sanitary sewer gravity collection system but does not have any statement regarding the pension and other post-employment benefits. Manager Toy then reported that this proposed Second Amendment to the 1987 Agreement between the City and the District does reference the pension and other post-employment benefits.

h. Adopt resolution authorizing the Chairman and the Secretary to enter into a Repayment Agreement for the 365 and 366 Margarita Drive Sewer Main Extension.

District Manager Toy reported that in 2002 the District entered into an agreement for the 365 and 366 Margarita Drive Sewer Main Extension, which was paid for by Ms. Theresa Campbell and Mr. Sasan Faramarzi, who own 366 Margarita

Drive, and by Mr. Frederick Reynolds, who was the former owner of 365 Margarita Drive. She also reported that Mr. Reynolds later sold his home to Mr. and Mrs. Patton prior to the installation of the sewer main extension, and the agreement for the 365 and 366 Margarita Drive Sewer Main Extension was between Ms. Campbell and Mr. Faramarzi and Mr. and Mrs. Patton, who were the new owners of 365 Margarita Drive, even though the former owner, Mr. Reynolds, paid for the sewer main extension. Manager Toy then reported that the sewer main was completed and accepted by the District in 2005, which means that the District now maintains this sewer main extension at no cost to the owners. Next, Manager Toy reported that Ms. Campbell and Mr. Faramarzi had been trying to enter into a Repayment Agreement with the other legal owner of the sewer main extension in order to help them recoup some of the monies that they had paid to install the sewer main extension. She reported that a Repayment Agreement would allow the original owners to charge a proportionate share of the total cost of the sewer main extension to any subsequent property owners that connect to the new sewer main. She then reported that in this instance, the appropriate legal "second owner" for the Repayment Agreement is unclear because Mr. Reynolds, the original owner of 365 Margarita Drive, put \$100,000 into an escrow account to help pay for the sewer main extension but sold the property to Mr. and Mrs. Patton during the construction of the sewer main extension, and Mr. and Mrs. Patton later sold the property to Mr. and Mrs. Lavelle. Manager Toy reported that now the District does not know whether the legal "second owner" for the Repayment Agreement should be Mr. Reynolds or Mr. and Mrs. Lavelle, who are the current owners of 365 Margarita Drive. She then reported that the District's legal counsel, Jack Govi, recommended that the District be listed as the legal second party to Ms. Campbell and Mr. Faramarzi on the Repayment Agreement in order to get the Repayment Agreement in place. The District would then put the second party's portion of any monies received in an escrow account until the dispute regarding the legal "second owner" has been resolved without the involvement of the District.

RECOMMENDATION:

Adopt resolution authorizing the District Manager/District Engineer to sign an Amendment to Agreement with Nute Engineering for additional construction related services for the Sun Valley Sewer Replacement Project, Phase 2.

BACKGROUND:

At the May Board Meeting, the Board awarded the Sun Valley Sewer Replacement Project, Phase 2, to Ranger Pipelines, Inc. The project consists of replacing and installing approximately 1 mile of sewer pipe on Solano and Alpine streets; California Avenue, from Humboldt Street to the end of Windsor Avenue; and Center Street, from J to K streets. It is anticipated that the construction will be completed by mid-February of 2017.

On July 25, 2016, our Assistant Civil Engineer, Ana Bernardes, gave the District a 2-week notice that she would be leaving her employment with the City of San Rafael, and her last day was August 5th. Ms. Bernardes was managing the Sun Valley project until her last day.

ANALYSIS:

Since the construction project is currently on-going, the District needs to fill the construction management role as seamlessly as possible. Since Nute Engineering designed the project and has been assisting the District during construction, they are the most familiarized with it. Therefore, staff asked Nute Engineering for a proposal to provide construction management assistance; and Gary Robards, who designed the project and assisted Ms. Bernardes during construction, will be assigned to perform this task.

Nute Engineering is proposing to perform this work on a time-and-materials basis for an amount not to exceed \$65,000.

FISCAL IMPACT:

The additional construction management assistance from Nute Engineering will be funded under the 80-Year Life Cycle Sewer Replacement Program from the current 2016-17 Budget.

ACTION REQUIRED:

Staff recommends that the Board adopt the resolution authorizing the District Manager/District Engineer to sign an Amendment to Agreement with Nute Engineering for additional construction related services for the Sun Valley Sewer Replacement Project, Phase 2.

As you requested, we are pleased to submit this letter outlining the additional engineering services requested for the above referenced project. These additional services should be considered in addition to our Schedule B from our previously approved proposal dated February 9, 2016.

BACKGROUND

Ranger Pipelines of San Francisco is currently in contract with the District for the Sun Valley Sewer Replacement Project Phase 2. Construction began in July and currently the A Line sewer main has been partially placed. Nute Engineering provided the project pipeline design and has been providing submittal review and other services under a typical scope of engineering construction services (Schedule B) intended to assist both the District staff and their Construction Inspector, Park Engineering of Orinda, CA.

Recent staff changes have compelled the District to request further construction engineering services from Nute Engineering for the remainder of the project. Nute Engineering is very familiar with the current project and our office is located in San Rafael, CA, just minutes away from the project area. Nute Engineering can begin providing these additional services immediately.

PROJECT DESCRIPTION

The Sun Valley Sewer Replacement Project Phase 2 is for the rehabilitation of various sewers in the Sun Valley Community and requires constructing new replacement sewers in the center of the streets and reconnecting the laterals to the new sewer lines. understands that since this is a residential community, it is important that the construction team continue to try to reduce the difficult construction impacts of this project to the community.

BASIC SERVICES TO BE PERFORMED BY THE ENGINEER

The following Schedule B is the previously approved scope of services we currently are providing on the above referenced Sun Valley Sewer Replacement Project Phase 2. Schedule B is reproduced in the attached table.

Schedule B Services - Phase 2 - Design Services During Construction

- 1. Attend preconstruction meeting.
- 2. Provide one set offset stakes designating the alignment and depth of the new sewer and prepare grade sheets.
- 3. Review the contractor's submittals and working drawings as necessary.
- 4. Attend weekly construction meetings as necessary.
- 5. Evaluate proposals for modifications to the contract work and prepare change orders to the contract for the District's approval, to include modifications in the contract.
- 6. Prepare a set of record drawings for the project.

For the new requested services we are providing a Schedule C that shall be used in conjunction with Schedule B.

Schedule C Services - Phase 2 - Construction Management Assistance

- 1. Provide Daily Construction Manager oversight Gary Robards, PE will assume overall construction management duties from the District's departing staff engineer on August 8' 2016. This will include daily coordination as necessary with the construction inspector and District Staff. The existing project construction inspector will be the primary contact for the contractor in the field, as well as homeowners, but Nute Engineering will assist to make sure the lines of communication from the residents stay open to the project team.
- 2. Conduct and document weekly project meetings Gary will prepare agendas, conduct weekly meetings and complete the meeting minutes.
- 3. Coordinate and track submittals, RFI's Nute Engineering will complete our Schedule B services with as needed coordination with District Inspector and Staff.
- 4. Prepare and submit weekly progress reports to the District Time for preparation of these reports will be included in Task 1.
- 5. Review pay requests and recommend payment to the District Nute Engineering will coordinate with the construction inspector and prepare the pay request for signature.

- 6. Review and track project schedule Time for this task will be included in Task 2.
- Determine Changed Conditions In addition to Schedule B Tasks for Changed condition evaluation, Nute Engineering will coordinate with the construction inspector, the contractors representative, and District Staff to resolve changed condition claims by the contractor.

SERVICES NOT INCLUDED IN THIS PROPOSAL

It is understood that the following services are outside the scope of this proposal and will be provided by others:

- 1. Geotechnical engineering and soil contamination investigation services.
- 2. Hazardous material investigations, assessment or removal.
- 3. Potholing of underground utilities.
- 4. Environmental review or preparation of an environmental impact report of the project.
- 5. Payment of permit application fees.
- 6. Title reports or rights of entries.
- 7. Legal services in connection with the project.
- 8. On-site inspection services.

ENGINEERING FEE

We propose to do all the work on a time and materials basis to be billed according to the Schedule of Hourly Rates attached hereto as Attachment A. The estimated labor hours and costs for the work by task and job classification are shown in Attachment B. The budget for the three schedules is given below.
