REPORT TO GENERAL PLAN 2040 STEERING COMMITTEE

Subject: Discussion of Culture and Arts Element Policy Audit

EXECUTIVE SUMMARY

Agenda Item 5.E addresses the 2040 General Plan Culture and Arts Element. Staff has completed a first-pass "audit" of this element, with recommendations for editing existing policies and programs, and a list of potential topics to be added. The Committee will be invited to weigh in on this topic before staff prepares the first draft of the revised policies and programs.

REPORT

Background

Culture and arts is not a required element of the General Plan. However, San Rafael added a Culture and Arts Element to the Plan in 2004, recognizing the importance of this topic to the community. The Element recognizes the value of the arts to connect people, cross cultural boundaries, and enhance civic life.

What's in the Culture and Arts Element Now?

The General Plan 2020 Culture and Arts Element can be reviewed here. The Element begins by describing the value of arts to the community. It presents policies to sustain San Rafael as the County's cultural hub, develop an arts plan, promote cultural arts programming, invest in public art, support community arts projects, encourage special events, and sustain Falkirk Center. The Element also includes policies relating to the public library, followed by a series of policies on historic preservation and protection of San Rafael's cultural heritage.

"Arts and Culture" will remain a General Plan Element in the 2040 Plan. However, staff is considering moving the historic preservation goal and policies from this chapter to the Community Design Element, where are already historic preservation policies and programs already reside. In addition, staff is considering moving the library policies to the Community Services and Infrastructure Element, where similar topics (schools, police and fire facilities, community centers, etc.) will be addressed.

Policy Audit

The remainder of this report presents the Culture and Arts Element goal, policies, and programs, along with staff recommendations. The matrix includes a column for Committee members to record their thoughts or ideas about the policies, programs, and staff recommendations. Committee members are encouraged to review the matrix before the March meeting and be prepared to discuss the existing policies and programs at the meeting. Staff intends to solicit additional information on arts and culture policies this Spring through a focus group comprised of arts and cultural advocates. Staff is also coordinating with the Library Department on policies that may result from a citywide study of library needs that is now underway.

The policy audit will be provided to Committee members in Word format following the meeting on March 13. Staff will consider Committee input as the policies and programs are revised. The Committee will have an opportunity to review Draft new policies and programs at a future meeting.

ARTS AND CULTURE

- Creation of a Downtown Arts District
- Support for arts venues (galleries, indoor and outdoor performing spaces, theaters, cultural centers, etc.) in the city
- Recognizing and leveraging the economic value of arts/ cultural tourism/ entertainment
- Need for artist housing and affordable space for artists
- Incentives to include arts/public space in new development (height or floor area bonuses?)
- Use of color to enliven the cityscape
- Support for neighborhood fairs and gatherings
- Marketing and promotion of cultural events
- Access to funding and arts opportunities by disadvantaged communities
- Engaging the arts community in planning

HISTORIC PRESERVATION

- Add a policy that clarifies what should be considered "historic" (thresholds, etc.).
- Add a policy on economic benefits and opportunities related to historic preservation
- Address potential future nomination of properties to state and national registers?
- Add a policy on the sustainability benefits of preservation
- Engaging communities of color in documenting their histories in San Rafael/ places of importance
- Action program: Heritage trails or walking route?
- Add tribal resources policy (including treatment of sensitive resources, consultation with tribes, etc.)
- Address issues related to context-sensitive design adjacent to historic buildings (or cross-reference policies in Community Design Element on this topic)—what is "compatible" with historic context?
- There is nothing specific to the Civic Center—even though it's County property, it's still a City historic resource
- Recognition/ preservation of the "recent past" (1950s-60s)
- Historic landscapes and heritage trees?
- Enforcement (avoiding demolition by neglect)
