Report on Bid Opening for the 2018 Sewer Pipe Repair and Replacement

Project, Phase I, and Adopt Resolution to Award Contract

RECOMMENDATION:

Adopt resolution awarding contract to D'Arcy & Harty Construction, Inc., for the 2018 Sewer Pipe Repair and Replacement Project, Phase I, in the amount of \$1,144,633.00 for both Base Bid and Additive Alternate B.

BACKGROUND:

The 2018 Sewer Pipe Repair and Replacement Project, Phase I, includes the replacement of approximately 3,220 feet of six-inch vitrified clay pipe at the following locations:

- West Crescent Drive
- Center Street
- Laurel Place Easement
- Mission Avenue
- Union Street Easement
- Broadview Drive Easement
- Saint Francis Lane
- Altena Street Easement

This project was developed to repair some of our sewer pipes prior to the City of San Rafael's paving project that will be starting this summer and some pipes that require immediate attention that were discovered during routine maintenance.

The Bids for the 2018 Pipe Repair and Replacement Project were opened on March 7, 2019.

The following is the Engineer's Estimate and a list of the bids received.

ANALYSIS:

The Engineer's Estimate was \$1,355,000.00. D'Arcy & Harty Construction, Inc., with a base bid of \$1,148,833.00, was the lowest responsible bidder for this project. D'Arcy & Harty has worked on a couple of the District's projects, i.e. the Valley View/Fairhills Sewer Improvement Project (2012) and the Fremont/Upper Fremont Sewer Improvement Project (2014). They were both successful projects with no change orders. We have reviewed the bids and recommend that this project be awarded to D'Arcy & Harty Construction, Inc.

As part of the bid form, there were two additive alternates. Additive Alternate A is to install 335 feet of pipe at an easement off of Broadview Drive by pipe bursting instead of open cut. This method will cost \$70,350. After further review and consideration, staff determine that the existing pipe is too shallow to be pipe burst. Therefore, staff does not recommend this method of work.

Additive Alternate B is to install 100 feet of pipe at an easement off of Altena Street by pipe bursting instead of open cut. The proposed cost for this work is \$21,000. In this case, the existing pipe has sufficient cover to be pipe burst and will save the District \$4,200. (The base bid for open cut is \$25,200.)

D'Arcy & Harty Construction, Inc., proposes to perform the contract work for the following:

Additive Alternate B:

If the District does not award the project, staff would not have sufficient time to rebid and award the project prior to the City's paving project. Since the City has a 5-year moratorium for paved roads, the District would incur additional costs to pave the entire street or, at the minimum, the width of the street, depending upon the size of the repairs.

FISCAL IMPACT:

District staff will implement the construction management for the project. This project will be funded under the 80-Year Life Cycle Sewer Replacement Program from the 2018-19 Budget.

OPTIONS:

- 1) Staff recommends that the Board award the contract to D'Arcy & Harty Construction, Inc.
- 2) The Board may reject all bids and rebid the project. Staff does not recommend this option, since this will delay construction, and the City will proceed with its paving project.

ACTION REQUIRED:

Staff recommends that the Board adopt the resolution awarding contract to D'Arcy & Harty Construction, Inc., for the 2018 Sewer Pipe Repair and Replacement Project, Phase I, in the amount of \$1,144,633.00 for both the Base Bid and Additive Alternate B.

I request that you conduct a closed session during your regular meeting on March 13, 2019, to discuss the following matter: (1) significant exposure to litigation pursuant to California Government Code §54956.9(d)(2). In my opinion, public discussion of this matter would prejudice your position.

The specific reasons and the legal authority for the closed session are:

Government Code Section 54956.9(d)(2). A legislative body of a local agency may hold closed sessions with the local agency's designated representatives when a point has been reached where, in the opinion of the legislative body of the local agency on the advice of its legal counsel, based on existing facts and circumstances, there is a significant exposure to litigation against the local agency.

It should be noted that Government Code Section 54954.5 requires the Board to post a Closed Session item on the Board Agenda. With respect to the above referenced matter, you should include the number of potential cases and the fact that the Board will be meeting with counsel regarding the anticipated litigation. Please note that disclosure of the facts of this matter may, in my opinion, prejudice the District.
