Barry,

This letter from Shirley Fischer (attached) rather precisely highlights concerns I have shared regarding the General Plan Committee and the PDA and any possible subsequently formed committee to discuss the Northgate PDA.

- (1) My recollection is quite clear that the intent was to keep level of service AND VMT, especially for North San Rafael; however just like in the Civic Center Station Area Plan what is written and codified by staff is diametrically opposite the input of the community or even committee discussion
- (2) This highlights the major disconnect between city committees and input from the community which is summarily dismissed. If the PDA is sanctioned for North San Rafael I have zero trust in a city committee representing the views of the community given:
- (a) The incredibly short outreach process that reached few beyond the general plan committee, not the hundreds that it should have done
 - (b) The dismissal of input by Ethan Guy of concerns I voiced

I fear that we are now for certain back on the path of the Civic Center Station Area Plan Committee where we have a council with groupthink dismissing input and forgetting community input given in 2013-2014.

ACTIONS REQUESTED:

- (A) revise Mobility Element Policy M2.5 to continue the LOS policies in General Plan 2020
- (B) postpone any application for a PDA in North San Rafael until we can have 6 months of in person outreach meetings to discuss this.

Dear GP2040 Steering Committee,

I am writing to you as an individual with long-standing interest in planning for the future growth and well being of our city. Many of you know that I participated in the development of San Rafael's General Plan 2000, the North San Rafael Vision 2010, and General Plan 2020. I understand and appreciate the long hours you have dedicated to developing General Plan 2040.

I want to share several serious concerns about the Mobility Element of General Plan 2040, which you will be considering tonight.

At their December 2nd meeting, the San Rafael City Council decided to retain Level of Service (LOS) as an additional tool for looking at potential development in San Rafael as well as Vehicle Miles Traveled (VMT), which by state mandate must be used for evaluating project under CEQA regulations. The intent of the City Council's instructions to staff was quite clear: "LOS should be continued in the project application process so the best possible decision can be made."

Mobility Element Policy M2.5 Traffic Level of Service does not fulfil the Council's intent.

- It <u>removes the City's commitment</u> to "maintain adequate traffic levels of service (LOS) consistent with standards for signalized intersections in the A.M. and P. M. peak hours as shown below, except as provided for under (B) Arterial LOS" (GP2020, Policy C-5). Policy M2.5 nowhere states that the City has any commitment to requiring Los thresholds to be maintained. <u>Essentially, the City is backing out of enforcing any standards for controlling traffic congestion throughout the City.</u>
- In General Plan 2020, LOS (whether intersection or arterial) is clearly used for "analysis for any proposed development project" (GP2020, Policy C-5). Policy M2.5 not only removes this requirement, but also specifically delegates LOS to be only a tool for transportation planning and managing roadway operation.
- General Plan 2020 uses LOS as a standard in Evaluation of Project Merits and gives the City Council the
 authority to make exemptions from these standards (GP2020, Policy C-5C&D). Policy M2.5 removes this
 requirement for LOS to be evaluated in Project Merit Review and makes it only optional in conditions
 project approval. This eviscerates the City's authority, as stated in the current General Plan, to evaluate
 traffic impacts as a part of project approval.
- Rather than setting a clear and equitable policy mandating traffic studies as a baseline requirement for
 which the elected City Council is able to grant exemptions, Policy M2.5 invests in a single City employee
 (not the elected officials) the power to determine whether or not a project needs to conduct any traffic
 impact studies and whether or not such studies need to include projections of future traffic congestion
 and the project's impacts on that future traffic congestion. This is a strong deviation from San Rafael's
 previous General Plans. This delegation of authority to an employee who is not responsible to the
 public is unwise, unprecedented, undemocratic, and likely to make the City vulnerable to legal actions.

Finally, it is very disheartening to note that, inadvertently or intentionally, substantial comments by community individuals and organizations such as homeowner groups and Responsible Growth Marin have been totally ignored. Many of the above issues were raised in writing and in oral testimony at the December 2nd Council meeting, along with personal comments on the impact that allowing increasing traffic congestion has on residents' safety, health, emergency access, and quality of life. Residents urged the City to maintain an unbiased, enforceable system for controlling traffic congestion. Apparently, no attention was given to any of these comments, since *Policy M2.5* is essentially unchanged from its original presentation, with the exception of changing "should require traffic studies" to "may require traffic studies", thereby weakening the Policy even further.

In current discussions about San Rafael's potential application for PDA funding for a Northgate Precise Plan, many residents opposing the application have expressed concerns that the City does not listen to residents and that their desires will be overruled by the interests of City staff and special interest groups. Unfortunately, the disregarding of residents' comments on the Mobility Element reinforces rather than dissipates their concerns. This is a very poor precedent for beginning the process of creating a Precise or Specific Plan for North San Rafael.

I strongly advise the General Plan Steering Committee to direct staff to revise Mobility Element *Policy M2.5* to continue the LOS policies in General Plan 2020 and to reflect the City Council's December 2nd instructions.

Kate,

Outreach on the North San Rafael PDA has clearly failed, the application for PDA should be delayed until the next Plan Bay Area cycle at the very earliest.

- With such a rushed timeframe, and the twin distractions of BLM and a pandemic, people cannot
 pay the necessary attention to this important local issue (Nextdoor.com is overrun rifght now with
 political posts on other matters)
- Less than 100 people weighed into city Zoom meetings where most had less than 2 days notice
 to attend meetings during working hours, most attendees were the general plan committee
 members and local activists. By comparison in 2012-2013 hundreds of regular residents
 appealed at city hall to rescind the Civic Center PDA
- Even the survey I ran which previously garnered hundreds of responses only garnered 60 votes in 2 weeks, other Northgate polls I ran had 560 and 800+ responses

CLEAR BIAS DEMONSTRATED ON CITY'S NEIGHBORLAND PDA SITE

The city's own neighborland site, which I promoted on Nextdoor to thousands of residents, demonstrates a non-representative skew between a single poll question where fewer than 50% supported a PDA, with 31% opposing and 20% saying they needed more time; yet on Neighborland 6 out of 7 comments (a tiny number of people) are for the PDA. There is clearly a disjoint.

The way the PDA is presented on Neighborland is one-sided, solely promoting benefits while suppressing concerns and reasons to oppose the PDA, it is not balanced. I regret promoting this clearly biased website. It reads like a promotion to readers to support the PDA rather than a balanced pro / con ballot measure.

Please do point out how on the Neighborland Northgate PDA page (not in buried long linked documents) exactly how the city has presented the PDA in a balanced, neutral format? Where is prior loss of local control, shifting PDA definitions and Sacramento's constant, repeated encroachment with laws expanding definitions and intentions mentioned? This demonstrates the city's strong bias during the outreach process.

I realize how this has been predecided upon:

- the city's website demonstrates a clear, strong bias in favor of the PDA and does not display any reasons to oppose it
- once approved, council will shift the conversation to an appointed, non-representative committee like the General Plan committee, to form a precise plan presuming support for the PDA

The LWVMC believes that PDA designations in the Canal and Northgate would go far to encourage:


- * Integration of housing planning with land use and transportation planning and job development

Mayor Philips, Vice Mayor Colin and City Council Members:

As Executive Director of Resilient Shore, the San Rafael nonprofit project focused on flood risk reduction, sea level rise adaptation and transportation resilience and as a member of the 2040 General Plan Steering Committee, I support the above referenced resolution.

Each of the proposed PDAs have Steering Committee and community support for preparation of area plans. Each face unique challenges and opportunities brought on by economic, environmental and social change.

In my conversations with Paul Jensen, we discussed how the PDA designation provides the opportunities to apply for ABAG grants to fund preparation of specific or precise plans.

Northgate is in transition as a result of changing consumer purchasing trends, specifically the moving to online purchases from brick and mortar stores. This process has been accelerated by the Covid 19 Pandemic placing additional stress on most retail operations including credit tenants. It's likely when a new equilibrium is reached many Northgate tenants will not reopen. All traditional anchor stores may be gone. With current land uses in play, the city and the community have both an opportunity and obligation to reconsider the future of Northgate.

Land use decisions on a proposed Costco store and filling station are at the heart of the future of Northgate. These decisions are made more difficult by the tension between the city's fiscal health and community interests.

The North San Rafael community has already expressed support for creation of a mixed-use village center at Northgate through a visioning process. A specific plan is an appropriate step on the path toward implementing this vision and addressing questions such as Costco.

Together we can do this.

Resilient Shore's current focus is on working with the city to fund and prepare a community based shore and watershed Adaptation Plan from Point San Pedro to Point San Quentin. This is the area identified by the BCDC Adapting to Rising Tides Bay Area Report as the San Rafael Operational Landscape Unit (OLU). The Draft 2040 General Plan identifies the Adaptation Plan as a policy and action. The OLU extends beyond the proposed Southeast San Rafael/Canal PDA boundaries. Regardless, the lion's share of San Rafael's at-risk community and regional assets are located within the proposed PDA.

Addressing the PDA's three major environmental issues: flooding, sea level rise adaptation and transportation (specifically improved access and egress) will be existential requirements. An Adaptation Plan and a specific plan will be needed to protect Southeast San Rafael, our city's economic engine, the Canal Neighborhood and homes for approximately one third of our population. A regionally funded specific plan can address issues including protection of existing and development of new affordable housing, protection of existing critical service industries, new commercial and residential development, parks and open space, habitat restoration and other stakeholder goals. It also should address mobility and transportation solutions.

An Adaptation Plan for the San Rafael OLU is a deeper dive effort that will require separate funding. Our estimate is \$2,000,000 including programmatic environmental clearance. This plan will provide a blue print for individual adaption projects. These can proceed based on risk profile, funding, design, permitting, construction and governance including operation and maintenance.

The Adaptation Plan sets out adaptation solutions and how to achieve them. A Southeast San Rafael/Canal specific plan sets out community design, mobility, social, economic, environmental, land use and implementation policies to strengthen our economic engine. The two are interrelated.

While external funding for implementation of projects is needed it will only go so far in a highly competitive environment. A robust economic engine must exist to contribute a local share and help fund both transportation and adaptation solutions.

These two planning efforts are of existential importance to the future of our city. PDA designations are helpful steps in securing a resilient and vibrant future for San Rafael.

Marin Environmental Housing Collaborative (MEHC) is a consortium of advocates building support for projects and policies that advance affordable housing as well as environmental integrity and social justice.

We support Staff's recommendation that the City submit to MTC its Letter of Intent to designate two Priority Development Areas for the next cycle of Plan Bay Area: North San Rafael and Southeast San Rafael/Canal. While PDA designations would bring valuable funding opportunities for much needed community-driven planning efforts, they would not obligate the City beyond using the funds to support planning.

MEHC believes that deep and coordinated planning is necessary for these two areas of San Rafael, as we anticipate extraordinary societal and environmental changes over the next 20–30 years in technology, demographics, business and commerce, and ways of working and getting around. - The Northgate Mall area has been in serious trouble for years and is currently run down and a terrible eyesore in our neighborhood.
- Mall owners Merlone Geier promised to create a town center for Terra Linda at the Northgate properties, but their only proposal is now a Costco which will destroy the mall and the neighborhood.

My wife and I are writing to voice our support for the Priority Development Area designation for the Northgate Mall. We are new members of the Terra Linda neighborhood with an eight-year-old son and ten-year-old daughter. We believe turning Northgate into a vibrant mixed-use neighborhood and town center would benefit the community in a number of ways.

It would increase much needed property taxes that would be used for schools. I learned at the last School Board meeting that Miller Creek is the least funded school district in Marin County. This is due to

lower property taxes compared to other communities. The prospect of the mall continuing to decline would exacerbate the problem while redevelopment would improve the situation.

It would give the people of the neighborhoods of Northern San Rafael and visitors an exciting new place to gather, have fun, dine, experience art, experience new park-like spaces, etc., thus improving the sense of pride, health and general happiness of the community.
