
Issue: Historic Resources

- Plan includes an updated inventory of historic resources
- Working now with property owners and stakeholder groups to address:
 - Survey findings
 - Development standards and procedures
- Post-card noticing of owners underway
- Webinars set for 2/18, 2/24, 2/25
- Comments on the inventory are being treated as EIR comments



Issue: Height and Density Bonuses

- Plan provides for 10' and 20' height bonuses for projects with affordable housing and other community benefits
- Commenters seek clarity on definition of "affordable" and how bonuses will be awarded
- Commenters seek clarity on how Statemandated density bonuses will be calculated when Plan does not use density
- City seeking legal counsel on best practices for applying density bonuses to Form Based Codes



Issue: 4th Street as a "Pedestrian" Street


- Plan acknowledges opportunities for "Shared Street"
- GP 2040 Steering Committee did not support permanently closing 4th Street to vehicle traffic
- Commissioners and several commenters suggested stronger case for changing street's design and function
- Supplemental guidance may be needed



Issue: Additional Urban Design Ideas

Sustainable San Rafael Letter suggests additional design ideas

- Plaza on west side of tracks at Bettini Transit Center
- Extend 4th St "shared street" west to B Street
- Ped safety improvements on 2nd and 3rd (at A, B, Lindaro)
- Open space at 4th and E SW corner
- Taller heights at 4th and E
- Design Second St and Tamalpais bike paths for multi-use
- Enhance 4th and Grand in Montecito
- Ensure solar access





Issue: Expand Plan Boundary at 4th/ Grand
