BICYCLE AND PEDESTRIAN ADVISORY COMMITTEE

ANNUAL REPORT, 2020

MISSION:

The goal of the Bicycle and Pedestrian Advisory Committee is to promote bicycling and walking as viable means of transportation throughout San Rafael; to provide conceptual input on public bicycle and pedestrian infrastructure projects; and to support the implementation of the City's Bicycle and Pedestrian Master Plan.

MEMBERSHIP:

2020 HIGHLIGHTS:

- The Committee pivoted to virtual meetings starting in June. The only regularly scheduled meeting that was missed was April. The virtual meetings have allowed the committee and staff to run meetings more smoothly, as public comments are managed by staff and the chair on Zoom.
- The General Plan 2040 Steering Committee is on-going and DJ Allison continues to serve as designated representative and attends meetings. Jimmy Geraghty serves as the alternate.
- City staff implemented the plan for proposed bicycle parking on Fourth Street and met the Bike and Pedestrian Master Plan (BPMP) goal of four bike racks per block. Just one of many challenges due to COVID-19, was working with many restaurants and retailers to make sure the bike racks did not encroach into their new outdoor dining spaces.
- The Multi-Use Path (MUP) from Rice to Andersen was completed in 2019 but the MUP from Second Street to Rice Drive was underfunded. City staff and BPAC worked together to come up with a plan to make Francisco Boulevard West one-way southbound and use the other side of the street for a protected two-way cycle track. The design and construction was completed in 2020. This provides a protected and separated bicycle and pedestrian facility from Larkspur all the way to central San Rafael.
- The City has been referencing a prioritization and ranking of fifty uncontrolled crossing locations in San Rafael. After completing the basic improvements (red curb, striping, signage) in 2019, the City and BPAC worked to find funding for the

enhanced improvements, such as rectangular rapid flashing beacons (RRFBs) and bulb-outs. Through Measure A and Lifeline grants, another nine locations were designed for improvements that included RRFBs, bulb-outs, and street lighting. Construction is expected in 2021.

- The committee continued to provide input on projects occurring around the City, including Third Street/Hetherington Street improvements, Third Street Rehabilitation, and the Transit Center Relocation.
- Collaborated with City staff, Metropolitan Transportation Commission (MTC) staff, Bay Area Toll Authority (BATA) staff, and consultants to find a way to improve the connection from Francisco Boulevard East to the Sir Francis Drake overcrossing. Striping and signage improvements at Francisco Boulevard East/Grange Avenue were completed in December, improving conditions for the bicyclists using the Richmond-San Rafael bridge to travel between the East Bay and the North Bay.

2021 GOALS:

- Continue working towards more stream-lined meetings, with scripts to help the committee stay on task.
- Improve transparency for the public by including staff reports and presentations in the agenda packet for everyone's review prior to meetings.
- Begin a rotation of committee chair and vice-chair, based on seniority.
- Continue providing input regarding pedestrian and bicyclist connections to new developments.
- Assist when possible with community outreach for bicycle and pedestrian projects, especially those listed within the new Bicycle and Pedestrian Master Plan.
- Identify locations where wayfinding signage could be improved and encourage City staff to complete this project.
- Support our local Safe Routes to Schools task forces when and where possible and adapt to the new ways of social distancing.
- Provide support for grant applications by submitting letters of support to City staff.
- Play an active role in providing input to the City Council and Public Works regarding the Transit Center relocation project, and its integration into the Bicycle and Pedestrian Master Plan.
- Support Public Works in improving bicycle and pedestrian safety throughout the City.



CITIZENS ADVISORY COMMITTEE

(ECONOMIC DEVELOPMENT AND AFFORDABLE HOUSING)

2020 HIGHLIGHTS:

San Rafael Fire Commission continued to advocate for the San Rafael Fire Department and obtain community support for fire safety.

This past year, several critical achievements have come to fruition:

- Opening of the new Public Safety Center
- Final adoption of the San Rafael Wildfire Prevention and Protection Action Plan (WPPAP)
- Participation in the Marin Wildfire Prevention Authority (MWPA) and setup of expanded defensible space inspection program in San Rafael
- Continued material support for the San Rafael Fire Foundation (SRFF)
- Participation in departmental milestones throughout the year, including badge pinnings, promotions, retirements, and new firefighter graduation ceremonies; and
- Leadership and support for other City agencies and the community at large during the ongoing COVID-19 emergency.

Other notable contributions by the members of the Fire Commission include:

- Commissioners welcomed San Rafael's new Fire Chief, Darin White, in April 2020. Chief White brings 30 years of Fire Service experience, including as Fire Chief for the City of Oakland, overseeing 25 fire stations and 60,000 annual emergency calls.
- Commissioners made the difficult decision to cancel the annual Crab Feed fundraiser for the San Rafael Fire Foundation due to concerns around COVID-19 safety.
- Commissioners Steve Mizroch and Larry Luckham, who were appointed to the San Rafael Wildfire Advisory Committee under the City Council's ad hoc Subcommittee for Wildfire Prevention in 2019, continued to provide guidance during Committee meetings. The Committee's review of the San Rafael WPPAP culminated in adoption of a revised Action Plan by the San Rafael City Council in August 2020.
- Commissioner Larry Luckham continued to photographically document San Rafael Fire Department events on The Photo 50 Project site (<http://www.srphoto50.com/TOC.html>), including Academy 20-1 Graduation and a tour of the new Public Safety Center. Additionally, Larry continues to provide historic photographs and other materials to the new fire stations in support of efforts to maintain the history of the Department for this generation and those that will follow.
- Commissioner Stan Burford was a forceful and committed proponent of the MWPA, speaking on behalf of the Commission and helping to gather support for Measure C on the March 2020 ballot. After the passage of Measure C, Commissioners provided guidance to the Fire Department on how best to leverage the new Authority to protect San Rafael homes and businesses from wildfire.

- Commissioner Tom Weathers, a highly regarded legal expert, continued to support the Fire Commission and Fire Foundation with his expertise.
- Commissioner Nadine Hade provides fiscal guidance and expertise to the Commission as well as participating in events in support of the San Rafael Fire Department and the department's use of MWPA funding.
- Commissioner Eli Hill provided support and expertise around data collection and visualization as well as participating in events in support of the San Rafael Fire Department.
- Commissioner David Fonkalsrud provides strategic guidance around public relations and community safety/engagement as well as participating in events in support of the San Rafael Fire Department.
- Commissioners provided support for Measure R, a successful sales-tax initiative on the November 2020 ballot. Measure R will provide additional resources for the Fire Department and other City Departments.
- The Commissioners continued to provide financial support to the members of the San Rafael Fire Department who needed Class A uniform items.
- The Commissioners have pledged support for technological needs at the new Public Safety Center.
- The Commissioners enabled the AmeriCorp and NCCC St. Louis volunteers to have an enjoyable Thanksgiving meal by donating funds to ensure they would be able to eat while far away from home and the possibility of a home cooked meal.

2021 GOALS:

- Act as a sounding board for the Fire Chief and Chief Officers via monthly meetings.
- Continued monthly education of Fire Commission members to goals, objectives & operations.
- Promote cooperation between the Fire Commission and San Rafael Fire Foundation by mutual support during fund raising efforts.
- Participate in departmental ceremonies (badge pinning, promotions, retirements and recognitions).
- Support morale within the Department among its members.
- Continue to advise and support the "Historical San Rafael Public Safety" exhibit in the lobby of the Public Safety Center.
- Support the implementation of the Wildfire Prevention and Protective Action Plan and the continued development of the Marin Wildfire Prevention Authority.
- Support the prudent and responsible stewardship of additional funding to the Fire Department provided by the passage of Measure R.
- Resurrection of the annual Crab Feed fundraiser (post pandemic)

The City of San Rafael Measure E Oversight Committee met on November 30, 2020 and received a detailed report from the City of San Rafael Finance Director, Nadine Atieh Hade on the receipt and expenditure of funds during the fiscal year July 1, 2019 to June 30, 2020 pursuant to voter approved Measure E (San Rafael Ordinance 1913).

The Measure E Oversight Committee is required to review the collection, expenditure, and prioritization of the use of these funds, and report to the City Council and the community annually on the expenditures under Guidelines and Policy adopted by the San Rafael City Council. After review, the Measure E Oversight Committee finds that these funds were properly allocated in accordance with the Measure and approved guidelines.
