Dear Mayor Colin and Councilmembers, Bushey, Kertz, Hill, and Llorens Gulati:

I have been a resident of San Rafael for the last 33 years, and a member Congregation Rodef Sholom, which is a member of the Marin Organizing Committee. I urge the Council to protect our city's renters, many of whom are essential workers, by passing an eviction moratorium for those unable to pay rent.

State protections end June 30 and there's no indication at this time if an extension will pass. The County's rental assistance program has been slow and will not reach those most in-need in time to save them from eviction. Many of these tenants have been depending on the County's rental assistance program to pay, at the very least, the 25% to keep them housed. However, the County's rental assistance program has been slow and inflexible due to State guidelines and the overwhelming need. With less than 2 weeks left, the County is only now starting to process the 25% payments for tenants whose landlords have refused to participate in the program. **Tenants need time for the rental assistance program to work.**

I am proud of the work that the San Rafael City Council has taken in the past to provide protection for our most vulnerable residents. As our city has the largest population of renters in the County, due to the Covid-19 public health emergency please pass an eviction moratorium for these residents through September 30, 2021.
