# **Appendix A: Implementation Matrix**

The Implementation Matrix provides a strategic framework for implementing General Plan 2040. The Plan identifies hundreds of programs to implement local policies and achieve the City's goals. Most are ongoing measures to be implemented through the operating procedures of City departments. Some are specific activities to be implemented in the years after Plan adoption, including additional plans, studies, ordinances, and capital improvement projects. Many of the programs provide guidance for development review, service delivery, budgeting, public participation and communication, and administration of community development functions.

The Matrix is organized by Plan Element. It includes 12 individual tables, covering all chapters of the Plan except Housing, which has its own Action Plan. Each table includes the following information:

Column 1: Program ID #. This corresponds to the program numbers used in the General Plan.

**Column 2: Program Description.** This is an <u>abridged</u> description of the program. The General Plan itself should be consulted for the full program description.

**Column 3: Timeframe.** This indicates whether the program is an ongoing initiative, or whether it is short-term, mid-term, or long-term in nature. Ongoing initiatives include day to day tasks that are currently carried out by each City department, as well as new activities that may be pursued in the future. The timeframe for other activities is as follows:

- Short-term actions are those to be implemented in the next four years. The highest priority short-term actions are highlighted in **bold text**.
- Mid-term actions are those to be implemented in the next five to ten years
- Long-term actions are those to be implemented in the next 10 to 20 years

The timeframes are intended only as guidelines. If funding becomes available for a long-term initiative, it may be pursued immediately. Likewise, if it is infeasible to achieve a short-term action in the next four years due to funding constraints or limited staff resources, it may be carried forward. The General Plan progress report provides a useful tool for reporting the status of various initiatives.

**Column 4: Responsible Departments or Agencies.** This column lists the City departments responsible for carrying out the program listed. In most cases, multiple departments are identified. Bold font is used to indicate the department with primary responsibility. The other departments are expected to provide a supporting role. In a few cases, "other" entities are indicated—this might include the County, special districts, agencies such as TAM, local utilities, or the private sector.

Table A-1 on the following pages shows the acronyms used for each department.

**Column 5: Resources.** This column indicates potential resources to carry out the program, such as staff time, bonds, grants, partnerships, assessments, volunteers, fees, fines, and private sector contributions. Implementation of each program may depend on the availability of the resources shown in the table.

**Columns 6-11: Applicable Guiding Principles.** Chapter 2 of the General Plan identified six guiding principles that underpin the Plan. The "check" marks in Columns 6-11 indicate which specific principles are advanced by the program.

Each Implementation Matrix begins with a list of performance measures or indicators that may be used to monitor implementation progress or provide a benchmark for planning and development review. In some cases, an actual numeric standard is provided (repeating a standard expressed in the text). In other cases, potential future metrics are suggested but no specific targets are provided. The City may develop numeric targets for these criteria in the future, as data, technology, and resources allow. When developing metrics, it is important to consider their context and intent so that they are meaningful and can inform policy choices in a constructive way.
