Dear Planning Commissioners:

On behalf of the San Rafael Chamber of Commerce which represents nearly 600 Marin County employers with over 26,000 employees across 25 industry sectors, I write to express our support for the mixed-use project known as The Neighborhood at Los Gamos in San Rafael.

The San Rafael Chamber has made the production of new housing units a top priority focus and supports new housing production that is attainable by our local workforce. The Los Gamos project would create 192 apartments, including 20 low-income units, which would increase our housing supply and contribute towards our desperate need for new housing units. Additional features of the project include a neighborhood market for residents and local professionals along Los Gamos, compelling public amenities, and an environmentally sensitive design.

Marin employers repeatedly report they cannot recruit and retain enough employees to grow their businesses. We recognize that the need for more workforce housing is crucial to securing our economic future. The high cost of home sales and rents has forced our workforce to live elsewhere and commute for hours every day to reach their employers. The status quo is no longer sustainable. We have a limited number of large sites that can accommodate residential projects that have the potential to make a dent in our housing crisis. This development is an ideal use of a nearly 11-acre site along the Highway 101 for high density to mid-level residential units. The project's close proximity to jobs, transit, and nearby amenities reflects key elements of good planning principles and thoughtful growth.

As San Rafael continues to recover from the ongoing pandemic, this project also would generate jobs and significant revenue during its construction phase as well as long-term revenue from its future residents. The positive impacts of this development would ripple through our local economy in the form of new sales tax revenue, sales to local businesses, and sizable project-related fees to the city.



After a thorough review of the project's design and the requested approvals from the City, the Chamber urges approval of The Neighborhood at Los Gamos. This project has been in the pipeline for over two years, and we encourage you to take this rare opportunity to create the type of housing that our community badly needs.
