TITLE: NOMINATION AND APPOINTMENTMENT OF CHAIR AND VICE CHAIR FOR THE PUBLIC ART REVIEW BOARD

RECOMMENDATION:

That the Public Art Review Board nominate and appoint a Chair and Vice Chair for the period January 2023 – December 2023.

BACKGROUND:

As part of the Public Art Review Board (Board) bylaws, the Board is responsible for appointing one representative as Board Chair, and one representative as Vice-Chair to the Board.

The Chair and Vice Chair shall serve a term of one (1) year, but not more than two (2) consecutive terms. However, if there is a vacancy, the Board has the authority to extend the current representative's term at their discretion.

DISCUSSION

Since this is a new Board, Staff Liaison Veramay is acting as the Board Chair for the inaugural meeting. The Board Chair and Vice Chair have distinct responsibilities from those of other Board Members and must be appointed.

The duties of the Chair include:

- 1. Ensure that consideration of items on the agenda move along without delay.
- 2. Ensure that petitioners, proponents, and opponents are heard.
- 3. Ensure that decorum is maintained at the meeting.
- 4. In presiding over agendized matters where the public has provided testimony and/or raised questions, the Chair should do the following:
 - a. Direct questions or comments requiring a response to staff for a response.
 - b. If necessary, help keep Commissioners' questions relevant to the matter being considered by the BCC.
 - c. If necessary, consider calling for a brief recess if orderly conduct of the meeting is being disrupted.
- 5. Announce the decision of the BCC on all subjects.
- 6. Ensure that each member of the BCC is provided an opportunity to completely express their views on items of business, the Chair should see that each Commissioner has been recognized by the Chair and given the opportunity to provide feedback.

7. Correspond to the City Council on behalf of the BCC, provided that opinions expressed on behalf of the BCC or City government are consistent with the consensus of the BCC.

In the absence of the Chair, a Vice-Chair shall possess all powers of the Chair and be subject to all prescribed duties for that position during the meeting.

Nomination of Board Members to serve as Chair and Vice-Chair for the coming year can be made by any of the current Commissioners in attendance at the meeting when nominations are made.
