Marin Wildfire Prevention Authority-Vegetation Management

On Thursday May 18, 2023, the Marin Wildfire Prevention Authority approved the FY 2023-24 Workplan and Budget. The Workplan is the fourth year/iteration of effort by the Operations Committee and Advisory Technical Committees collective efforts to build a comprehensive and effective strategy to reduce wildfire risk throughout Marin County. The workplan includes but is not limited to: strategic shaded fuel breaks, goat grazing, and other vegetation management activities near homes to reduce fire intensity and severity, rate of spread, and potential for burning embers to be carried downwind into adjacent communities.

Additionally, the Workplan included vegetation management projects to reduce risk around key evacuation routes and vulnerable communities, funding dedicated to home hardening and defensible space inspections, as well as grants to support residents working to implement the recommendations provided during those inspections. Funding is available for free chipper programs for residents performing their own defensible space work, evacuation, and alert systems, including auditory alert systems, online evacuation management systems, and additional signage. A comprehensive public education campaign will remain a key aspect of the outreach and information sharing, effective and efficient environmental compliance practices will continue to play a key role in wildfire project proposals and mitigation efforts.

Promotional Ceremony and Graduation of Fire Academy 25

Four of the six members of Fire Academy 25 have made it to successful completion of their probationary periods and will be honored on June 22, 2023, at Station 52 from 10:00 a.m. until noon. Each of these individuals persevered and had been provided with an opportunity to succeed by completing intensive and focused EMS training and skills development immediately following their academy's fire-based curriculum and training. We are looking forward to their future successes.

Also on June 22, we will celebrate the promotion of Grant Saysette to the rank of Fire Captain, and Colton Beal to the rank of Engineer. Last, but not least, we have finally secured a Training Coordinator for our Department wide goals of ongoing training, skill development, and proficiency. On May 16, 2023, Captain Ryan Goodwin was appointed to the role of Training Coordinator, and he will be celebrated on June 22, 2023 for this accomplishment.

Station 54





On Tuesday May 23, 2023, San Rafael Police arrested Kevin Cook, a 37-year-old San Rafael resident, after he caused over \$5,000 in damage to a San Rafael Fire Station and later threw a can of beer at a moving police car. Cook was booked into the Marin County Jail on felony and misdemeanor charges.

At 3:30 AM, Cook walked to San Rafael's Fire Station #54 and began throwing baseball-sized rocks at the front of the newly remodeled and constructed building. Cook threw about 30 rocks over the fence in about an hour, causing over \$5,000.00 in estimated damage to the front of the building. Cook broke out a window, destroyed several glass railings, and damaged the stucco on the façade of the building.

The East San Rafael fire station, currently under construction and undergoing a yearlong renovation to bring it up to modern-day use and seismic safety standards, is currently closed to the public and was fenced off. When construction workers arrived later in the morning, they made a report to SRPD, and officers started looking for video surveillance to identify the suspect.

While the investigation was occurring into the vandalism at the fire station and just after 8:20 AM, Officers were driving on Bellam Boulevard in the area of Belvedere Street when Cook was seen walking on the sidewalk. As the police car got closer, Cook became agitated and threw a 24-ounce can of beer. The beer can struck the windshield, causing minor damage. The officers stopped and took Cook into custody. The officers were not injured in the incident.

It was quickly determined that Cook was the same person involved in the earlier vandalism at the fire station. Cook matched the description and was still wearing the same clothing as seen in the video surveillance. Cook was booked into the Marin County Jail for felony assault on police officers, felony vandalism, and misdemeanor vandalism and is being held to answer in lieu of \$50,000 bail. The two cases have been forwarded to the Marin County District Attorney's Office. (Story taken verbatim from the SRPD Press Release).
