**Subject:** Pint Size Lounge Music

Dear Mayor, City council, City Attorney, Planning Department, and City Clerk

I would prefer the Pint Size Lounge's music series, in its present form be discontinued. How about some non-amplified Jazz, Classical, or Blues?

**If you are going to approve this proposed music, please only allow a total of 3, non-amplified concerts in August, September, and October 6-9 PM!**

I'd like to note: **This proposed music series is in violation of Adam Violente's usage permits, which stipulates no amplified music inside his bar--let alone outside.** This music series detracts from nearby property owner's rent potential and property values. This music series is not in keeping with the promises Adam made in order to open, nor the concerns that previous City Council members looked to safeguard against. (Please see attached).

#### **Pint Size Usage Permit Not Honored**

I have included several documents illustrative of the fact that Adam has not abided by promises to the city nor nearby neighbors. There are letters and signatures from people years ago protesting the bar opening. All their concerns have been actualized over the years. Adam built and maintained an illegal back patio for years until noise complaints finally forced its closure. He has left his front and back doors wide open, played very loud amplified music, has never had a doorman and has no operable AC system. All of which are expressly spelled out in his usage permit.

More recently the Alcohol Beverage Control were misled into allowing for offsite open containers of beer and wine at the adjoining parklets, but had no knowledge of live music, which is expressly disallowed. Adam has been ignoring its usage permits, has a history of documented violations, and has attempted to trick, or coerce relevant entities.

#### **The Recent Survey**

We were encouraged by the recent appointment of Micah Hinkle who has been responsive and communitive. He told us that there would be a survey coming out that would be relegated to residents/owners within 300 feet of the event. The survey came out recently and there was no way to ensure that the respondents were in fact from the prescribed 300 foot radius.

There was no confirmatory code that needed to be entered, or even the requirement to list one's address. Literally anyone could respond throughout Marin, the Bay Area and beyond. Adam Violente has posted both on Facebook

and Instagram an invitation and link to the survey. Sarah Tipple previously relied on bar patron's letters of approval as a confirmatory green light to push this event through.

We feel that this survey's lacking is likely an administrative error, as opposed to an overt attempt to minimize nearby residents, unfortunately the outcome is the same. There was not an accurate, or equitable assessment from nearby residents, who matter the most.

- (a) The Applicants' business, the Pint Size Lounge, will serve a segment of the City's residents that are not currently being served, in that there is no facility, such as that proposed by Applicants, that is presently operated to specifically attract young adults with beer and wine and limited food services.
  - (b) The Applicants' business will serve the principles in the City's Downtown Vision, by providing evening entertainment opportunities.
  - (c) These findings are based upon the evidence in the Applicants' application, testimony of speakers at the Public Hearing on May 20, including the Applicants and persons who indicated they would use the Pint Size Lounge, and the City's Downtown Vision.
2. The Council conditionally accepted the assurances of Mr. Bennett and Mr. Violante that their facility would be operated so as not to present a nuisance with litter, noise, or loitering.

**BE IT FURTHER RESOLVED**, that the Chief of Police is directed to send a letter of Public Convenience and Necessity to the California Department of Alcohol Beverage Control subject to the following conditions:

1. This liquor license is for on sale beer and wine in conjunction with food and beverage service. Other allowed uses include one pool table, a maximum of four pinball machines, a projection-screen and a jukebox. Hours of operation are from 4:00 p.m. to 2:00 a.m. Any additional pool tables or coin-operated amusement devices are not allowed unless a use permit is approved by the Planning Commission. Minors are not permitted in this facility.

2. A floor plan showing the location of the proposed facilities must be submitted for the approval of the Fire, Police, and Planning Departments. All coin-operated amusement devices and the pool table must be operated in plain view of all persons, unobstructed by screens, blinds, stained windows, or other devices.

3. The maximum occupancy is 49 unless the Fire Department establishes a lower occupancy level.

4. Live entertainment is not permitted unless a use permit is approved by the Planning Commission. Noise generated within the facility shall not exceed 60 dB Ldn as measured outside the building. Exterior doors shall be equipped to close automatically to contain noise.

5. Adequate cooling and ventilation facilities shall be provided so that doors and windows can be closed. The business must be operated in compliance with the City's noise ordinance.

6. The sidewalk in front of the building shall be swept on a daily basis.

# USE PERMIT (2)

Important conditions in the Resolution include:

- The facility may not exceed the residential standards for noise generation; also, no live entertainment is permitted without a Use Permit.
- Sidewalks in front of the building would be swept on a daily basis and a portion of the block frontage would be cleaned for litter once a week.
- The facility must have a door-person, who will screen clients and who will urge people not to congregate in front of the facility.
- The applicant will be responsible for holding a monthly meeting with neighboring property owners/tenants for the first six months, and the Planning Department will attend.

The difficult issue to resolve in this case is loitering. As you know, everyone has the right to stand on the public sidewalk unless they are obstructing passage or being disorderly. The Pint Size Lounge operators expect that they can persuade any of their clients who do congregate on the sidewalk to move along for the sake of their business. The project sponsors also expect that they will not attract a clientele that will linger in front of their lounge. Nevertheless, the City will not be able to hold the operator responsible for the behavior of others on the sidewalk as long as it is within the law.

These conditions were reviewed by the operators and two of the three people who objected to the proposal at your hearing, Mr. Bruno Albin and Mr. Eric Frey. While they are concerned about the City's ability to deal effectively with loitering, they were in concurrence with the recommended conditions.

- (c) ON-SALE PUBLIC PREMISES (On-Sale General or On-Sale Beer and Wine only)  
Applicant is to submit diagram indicating what part of building is to be designated as the "public premises," and drinks may only be served in the area so designated. Post at or near each public entrance to the premises a clearly legible sign not less than 7" x 11" in size reading "No Persons Under 21 Allowed." A sign of like size and content shall be maintained at a prominent place in the interior of the premises. Keep one exterior entrance unlocked at all times while any member of the public is in such premises. Furnish, sell, or serve no meals of the variety and type served in a bona fide eating place. Sandwiches, beverages, salads, desserts, and similar short orders of food products may be sold and served as an incidental part of the principal business. Note that these requirements differ from the requirements as to on-sale beer licenses for public premises.

\* (The licensee may exercise off-sale privileges with respect to beer and wine.) \*

If only a barroom is designated as the "public premises," no service is permitted outside that room since it would involve a sale at a place not licensed by the Department.

A new on-sale general "public premises" license may not be issued except on a showing of substantial public demand. Therefore, such licenses may be obtained only by transfer.

- (d) ON-SALE BEER  
Issued to premises for consumption of beer alone on premises where food is served. "Food," as it pertains to on-sale beer licenses, includes sandwiches, hamburgers, hot dogs, pizza, tacos, salads, desserts (other than pre-packaged individual servings of ice cream, ice milk, or imitation ice cream), and similar short orders. (The licensee may exercise off-sale privileges.)

- (e) ON-SALE BEER PUBLIC PREMISES  
Issued to premises for consumption of beer alone on premises where no food is prepared and sold.

A sign reading "No Persons Under 21 Allowed" is required to be posted under the same conditions as in on-sale general or on-sale beer and wine public premises.

It has come to our attention that the Copa Club /aka Half Pint Cafe located at 1615 4th Street in San Rafael is applying for a new liquor license.

We, the neighboring merchants, residents and property owners have had to endure years of negative impacts on our once quiet community because the various owners of the Copa have either refused or been unable to control the sometimes unruly clientele that frequented their business. This was after the owners assured local merchants and residents that they (the Copa owners) would mitigate the negative impacts. We believe the negative impacts violated the conditions of the Copa's use permit.

★

Loud amplified music with the front and rear doors wide open has not been uncommon for the Copa over the years.

Large groups of Copa customers milling around and blocking the side walks in front of the Copa and other businesses has not been an uncommon sight in the past.

★

The parking at night has been a nightmare. The Copa has not mitigated the problem.

The Copa has been a magnet for skateboarders who have had a tendency to hang around and skateboard on the sidewalks well after 2:00am.

★

Graffiti and vandalism have been a weekly occurrence in the immediate area near the Copa.

★

Broken and empty beer bottles left on the sidewalk and neighborhood yards has been a common problem that the local businesses, property owners and residents have had to clean up.

★

The sidewalks have been littered with cigarette butts by customers outside the Copa.

On the corner of 4th and G streets, City planted flowers and plants were repeatedly trampled by customers of the Copa just "hangin' out" near the club.

City owned garbage cans outside the Copa were always

I am the owner of the buildings at 1616 - 1618 Fourth Street and 102-110 "G" Street. They have vandalized my building with graffiti time and time again. Even spraying my windows with paint. My awnings were cut in three different places and all had to be replaced at a great expense to me. Bottles, cigarette butts and other trash around the building have to be picked up on a daily basis. The city trash barrels are always overflowing. My elderly tenants are even afraid to leave their apartment because of the caliber of people that this business will attract. Loud music and noise also disturb the tenants. Since the Copa has closed it has been peaceful, with more people in the area doing business. These are my reasons that this license should be denied.

But most of these problems stopped not long ago.

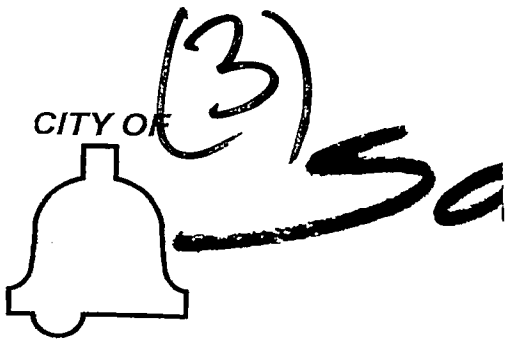
Our community has been quiet once again. It happened when the Copa closed their doors for business.

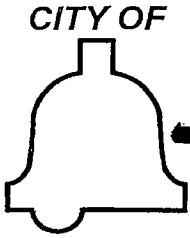

Dear Mr. Violante:

The City of San Rafael has received your applications referenced above. We are required by state law to review your application within 30 days of receipt to determine if we have the information necessary to deem it complete. Once the application is complete then we can begin formal processing and schedule a public hearing.

After review by City staff of the plans and other materials submitted with your application, and following the site visit conducted on Monday July 21<sup>st</sup>, we have found that the following information is still needed before we can deem the application complete:

1. Plans need to be revised to show ADA compliant access and ingress/egress to comply with building code occupancy requirements for use of the patio space. As we discussed, use of the patio would increase the site occupancy over 49 occupants which triggers a requirement for secondary ingress/egress and which must provide disabled access. If easements across adjacent properties are proposed, documentation will need to be provided to show the owners are willing to grant necessary easements.
2. A portion of the patio encroaches onto the adjacent property. Please correct or clarify and explain this condition on plans.
3. A use permit amendment would be required to use the patio area; either as an ancillary outdoor seating area or as an amendment to the business operations. A noise study would be required to demonstrate that use of the patio would not exceed noise standards. However, as discussed nighttime use is not likely possible due to adjacent residential uses and allowable 60ldn noise level limitations.

In addition to the above requirements, staff has identified the following design or use issues that should be addressed:

- As we discussed during the site visit, the use must retain its food service with beverage sales, including alcoholic beverages per the current use permit approval UP83-21, or obtain a use permit to operate as a bar/lounge as the primary use.

- The exterior face of the fence may require additional finish or covering to create a uniform design and appearance.

This information listed above is provided to assist you in the preparation of a development application that is complete for processing. Please submit three (3) sets of revised plans when you are ready to proceed. If revised plans are not received within **thirty (30) days** of the date of this letter, or by **September 4, 2008**, the application will be deemed withdrawn, unless an extension of time is requested. Any request for a time extension must be submitted in writing and must specify the reason(s) for the delay and the date on which the incompleteness items will be submitted to the Community Development Department.

Dear Mayor, City council, City Attorney, and Planning Department,

I would prefer the Pint Size Lounge's music series, in its present form be discontinued. How about some non-amplified Jazz, Classical, or Blues?

**If you are going to approve this proposed music, please only allow a total of 3, non-amplified concerts in August, September, and October 6-9 PM!**

I'd like to note: **This proposed music series is in violation of Adam Violente's usage permits, which stipulates no amplified music inside his bar--let alone outside.** This music series detracts from nearby property owner's rent potential and property values. This music series is not in keeping with the promises Adam made in order to open, nor the concerns that previous City Council members looked to safeguard against. (Please see attached).

#### **Pint Size Usage Permit Not Honored**

I have included several documents illustrative of the fact that Adam has not abided by promises to the city nor nearby neighbors. There are letters and signatures from people years ago protesting the bar opening. All their concerns have been actualized over the years. Adam built and maintained an illegal back patio for years until noise complaints finally forced its closure. He has left his front and back doors wide open, played very loud amplified music, has never had a doorman and has no operable AC system. All of which are expressly spelled out in his usage permit.

More recently the Alcohol Beverage Control were misled into allowing for offsite open containers of beer and wine at the adjoining parklets, but had no knowledge of live music, which is expressly disallowed. Adam has been ignoring its usage permits, has a history of documented violations, and has attempted to trick, or coerce relevant entities.

- Adam's Promises to the city and neighbors
- Protests and petitions from neighbors when Pint size initially attempted to open
- Police noise and nuisance reports from over the years
- Documents regarding his illegal Back patio

#### **The Recent Survey**

We were encouraged by the recent appointment of Micah Hinkle who has been responsive and communitive. He told us that there would be a survey coming out that would be relegated to residents/owners within 300 feet of the event. The survey came out recently and there was no way to ensure that the respondents were in fact from the prescribed 300 foot radius.

There was no confirmatory code that needed to be entered, or even the requirement to list one's address. Literally anyone could respond throughout Marin, the Bay Area and beyond. Adam Violente has posted both on Facebook and Instagram an invitation and link to the survey. Sarah Tipple previously relied on bar patron's letters of approval as a confirmatory green light to push this event through.

We feel that this survey's lacking is likely an administrative error, as opposed to an overt attempt to minimize nearby residents, unfortunately the outcome is the same. There was not an accurate, or equitable assessment from nearby residents, who matter the most.
