**TITLE: PARKS AND RECREATION COMMISSION PARK TOUR LOCATIONS
AND ROUTE OF TRAVEL**

RECOMMENDATION

Commissioners are encouraged to participate in an optional Parks Tour to Terra Linda Park, Peacock Gap Park, and Pickleweed Park.

BACKGROUND

The purpose of this park tour is to familiarize Park and Recreation Commissioners with three of the parks identified in the Park and Recreation Master Plan that have near-term priority projects. Commissioners will travel to Terra Linda Park, Peacock Gap Park, and Pickleweed Park for walking tours. At each location, Commissioners will have an opportunity to see the current condition of the park and learn about recommended priority projects.

The tour will begin at Terra Linda Park (670 Del Ganado Rd), then commissioners will travel to Peacock Gap Park (Peacock Drive), and Pickleweed Park (50 Canal St). A map of the tour locations is included in Attachment 1.
