# **STAFF COMMENTS**

### 4. Updates and Events of Interest

Chair Mason provided the following updates:

Canal Art Mural Proposal. Public Art Review Board also provide conditional approval of the project. Wall damage from window leaks may lead to a delay in the mural installation, still waiting for some design alterations and approvals before eventually going to the City Council for final project approval.

Four of our Canal Karate participants won first, second or third place awards at the Ozawa Cup International Karate Tournament in Las Vegas April 6-8. Additionally, 30 students advanced belt levels at the Canal Karate Belt Ceremony 5/31. Vice Mayor Llorens Gulati assisted with the presentation.

Community Center staff have partnered with Vivalon in offering a new program for older adults in the Canal community. "Bingocize" is a fall prevention course in a game-style format, combining Bingo with exercise for one's body, mind and spirit. The free class is offered in both Spanish and Vietnamese on Tuesdays on its own and on Wednesdays in partnership with our Multicultural Older Adult Program.

Program Coordinator Cristina Farhang was the special guest on Cuerpo Corazón Comunidad, a Spanish-language interview program broadcast on the radio and streamed on YouTube and Facebook Live. Cristina informed listeners of all the recreational opportunities, from preschool to adults, that are available this summer though the Recreation Division.

The community was treated to a free Marin Theatre Company performance of "WHERE DID WE SIT ON THE BUS?" on Friday, May 19th. The energetic, musical, theatrical experience examined what it means to be Latiné in America and was attended by youth and adults.

TITLE: Summer and Fall 2023 Program Overview

#### RECOMMENDATION

That the Pickleweed Advisory Committee receive the Summer and Fall 2023 Program Overview and provide comments.

#### **BACKGROUND**

Programs offered to the community at the Albert J. Boro Community Center are done so through facility rentals, co-sponsorships, partnerships, and directly through the Recreation Division with either staff led activities or with contract instructors.

It has long been the philosophy of the Center that the best way to capture the needs of the community is through a web of program providers that can best ebb and flow with trends to meet community needs. In order to best do this, the San Rafael City Council directed that non-profit and private residential rental rates be set at half the rental rates of the other San Rafael community centers so that agencies serving the Canal community, and the community itself, could better afford to utilize the Community Center. The City Council also created the Pickleweed Advisory Committee and empowered them to recommend rental fee reductions or waivers for organizations wanting to serve the Canal neighborhood and keep their programs affordable.

Like traditional recreation centers, City staff at the Albert J. Boro Community Center also develop programs to serve the community by contracting with specialized instructors, utilizing part-time employees and volunteers, or leading activities directly.
